A. RESOLUTION 80: A RESOLUTION OF THE BOARD OF THE NORTHWEST FOCAL POINT SENIOR CENTER DISTRICT APPROVING FISCAL YEAR 2016 BUDGET AMENDMENT 001; PROVIDING FOR APPROVAL OF ADDITIONAL EXPENDITURES THROUGH REALOCATION OF FUNDS.

The following motion was made by Mrs. Peerman, seconded for discussion by Mrs. Bryan:

Ms. Diaz explained that she is asking for a budget amendment because funds from the ADRC need to be spent by December 31, 2015. Wages and salary funds were not spent therefore she is asking for them to be reallocated in the following way: a portion to be paid into FRS, this will reduce the portion that the City pays for the 2015 fiscal year and part for the 2016 fiscal year; a portion to be used to paid towards the repair of the walk-in freezer at the Senior Center, and a portion to be used to fund a small bonus for Senior Center staff (\$600.00 for full time staff and \$300.00 for part time staff). Mrs. Peerman asks if this is all legal. Ms. Diaz said that this is legal since OAA funds would be used for the bonus given to staff that is paid with OAA funding.

3. PROJECT DIRECTOR'S REPORT

<u>Ms. Karin Diaz</u>, Project Director of the Northwest Focal Point Senior Center District (NWFPSCD), thanked the Board very much for approving the budget amendment and also thanked the City Manager and City Attorney for assisting during the process. Ms. Diaz reported that the two new vehicles, purchased through the 5310 FDOT grant have arrived and are operational at this time. On Friday, December 18 the Center celebrated the Senior Holiday Luncheon and Milton Peckman's band provided the musical entertainment.
