COMMISSIONER PEERMAN said that following the last meeting she looked at the Recycle Bank Program and determined that she saved a lot of money. She explained that her wife was able to order 5 magazines for a year with the Recycle Bank points. She thanked Director of Environmental and Engineering Services (DEES) Reddy Chitepu for his work on the Recycle Bank Program. She congratulated Vice Mayor Ruzzano and Commissioner Bryan for their appointments as Mayor and Vice Mayor. She commended Mayor Simone for her professionalism and strength during her term. She said that Mayor Simone represented the City Commission everywhere extremely well with dignity. She stated that she was very proud of the Mayor, as she accomplished everything while battling Cancer. She said that she respected, admired and was very proud of Mayor Simone for the job she did.

COMMISSIONER TALERICO congratulated the new Mayor and Vice Mayor, and commended outgoing Mayor Simone for her professionalism.

COMMISSIONER BRYAN thanked everyone for the appointment as Vice Mayor. She congratulated Vice Mayor Ruzzano and said it would be a privilege to work with him. She gave thoughts and prayers to Mayor Simone who she felt did a great job with high

decorum and hard work. She said her heart was heavy with deep sorrow for France and the people of Paris for the recent attacks. She spoke about the Harvest Drive 2015, which was in its 23rd year and allowed the children in the schools to help support two pantries throughout the year. She thanked the City Manager, City Clerk, Public Works and Staff for the excellent job they did and the amount of soup and toothpaste collected. She thanked everyone for the gift bags for the Veterans that contained letters from the students, which were very heartfelt. She thanked everyone for helping with the Dr. Martin Luther King celebration and the Together We Make It Great day event. She said that residents were being inspired to do community service projects, and she mentioned a Butterfly Garden in the Southgate Park. She noted that there was a commitment from an Art Teacher from Ramblewood Middle School who was a Margate resident, to work on a service project with Margate students. She noted that she recently attended the National League of Cities Conference in Nashville, Tennessee, which was a great learning experience. She showed pictures from her trip. She thanked the City Clerk, Assistant City Clerk and Staff for the annual report. She wished everyone a Happy Thanksgiving and invited everyone to the Northwest Focal Point Senior Center (NWFPSC) at 9:00 a.m.

VICE MAYOR RUZZANO stated that the School Board Representative Nora Rupert did a great job representing the City. He congratulated Commissioner Bryan on her appointment to Vice Mayor. He commended Mayor Simone for being very thorough and he appreciated and applauded her. He noted that there was a Community Redevelopment Agency (CRA) meeting last week and adding lights on Royal Palm Boulevard was discussed. He suggested getting a price to expand the additional lighting to Southgate Boulevard.

CITY MANAGER DOUGLAS E. SMITH stated that he would look into obtaining a price and report back to the Commission with an update.

VICE MAYOR RUZZANO thanked Director of Public Works Sam May for handling the problem regarding a lock at the Baseball Field. He thanked the City Manager for his assistance with the issue at Abundant Life. He thanked everyone for his appointment as Mayor, and also thanked his wife for her support.

MAYOR SIMONE noted that at the last meeting a percussion player from Stoneman Douglas High School came before the Commission for a scholarship; however, he did not mention all of his accomplishments at that time. She reported that he would be playing in the Macy's Day Great American Marching Bands on Thanksgiving Day. She said that he competed against students from more than 14,000 high schools and was 1 of only 2,500 in the past 10 years to play in the Great American Marching Bands. She felt that the City did the right thing in sending him to the parade based on all of his achievements. She stated that she was grateful and honored to have served as Mayor and said that working as a team with the Commissioners was a rewarding and fruitful experience. She stated that as City Government, the Commission had the responsibility to perform their duties in an open, ethical, impartial and professional manner. She said that together, the Commission achieved a more professional business like decorum to the meetings, and mutual respect for their differences of opinion. She thanked the Commission and residents for the opportunity to serve. She stated that many goals were reached by working together every day. She said that one was only as successful as the Staff behind them; therefore, she thanked the City Clerk's office; Joseph, Jennifer, Theresa, Carol, Carleen, Melissa, Annette and Thomasina for their support. She appreciated their advice, laughter, hard work, and making sure things run smoothly and efficiently. She also thanked the City Attorney Steinfeld and City Manager Smith, as well as Adam Reichbach, Nancy Popick and Alison Saffold, for their support and encouragement. She recognized all of the Department Heads for their tireless work making the City a better place every day. She thanked former Mayor Pam Donovan and former Mayor Joseph Varsallone for their support. She thanked Vice Mayor Ruzzano for serving and wished him the best as Mayor. She congratulated Commissioner Bryan for her appointment to Vice Mayor. She stated that Together, we truly make it great.

CITY ATTORNEY EUGENE STEINFELD congratulated the incoming Mayor and Vice Mayor. He also commended Mayor Simone for her leadership, which was rewarding, allowed the meetings to go smoother and quicker, and allowed more things to be done.

CITY CLERK JOSEPH J. KAVANAGH echoed the sentiments of the City Attorney to Mayor Simone and Vice Mayor Tommy Ruzzano. He felt that together they grew, but he also appreciated the advice and education they provided him. He congratulated Vice Mayor Ruzzano and Commissioner Bryan on their appointments as Mayor and Vice Mayor, and looked forward to working with them.

3) PUBLIC DISCUSSION

ANTHONY CAGGIANO, 7856 NW 1st Street, said that he spoke with former Mayor Joseph Varsallone who wanted to commend Mayor Simone, as well as congratulating the newly appointed Mayor and Vice Mayor. Mr. Caggiano thanked Mayor Simone for her service as Mayor. He stated that though he did not always agree with her positions, she was knowledgeable of the issues and did what she felt was best for the residents. He hoped her battle with health was won. He was pleased that Mayor Simone honored the precedent and tradition by voting for the Vice Mayor to succeed her for the 2015/2016 term. He asked that Mayor Simone give the new Mayor the benefit of her experience. He congratulated the new Mayor and Vice Mayor.

RICH POPOVIC, 6066 Winfield Boulevard, stated that he did not agree with anything the Mayor did and commented on the CRA property being sold, the Alzheimer Family Center, the millage rate, property taxes and the garbage contract.

MR. POPOVIC left the meeting after Mayor Simone asked him to leave due to his

language and calling out of order.

COMMISSIONER PEERMAN said that it was not possible to make everyone happy, but she reiterated that the Mayor was a good Mayor.

CITY ATTORNEY EUGENE STEINFELD noted that Mr. Popovic had been asked to leave several times over the past year.

COMMISSIONER TALERICO and COMMISSIONER BRYAN apologized to the young people in the audience for the behavior that was displayed. They thanked everyone for attending and invited them to attend more meetings.

RICK RICCARDI, 4829 South Hemingway Circle, said that he was the President of the Chamber of Commerce. He thanked the Commission for the way they ran the City. He said that he was proud as a citizen, business owner and working with the Chamber of Commerce.

NICOLE COLLINS, 5161 SW 16th Court, stated that on behalf of the Margate Shetland All-Star Team, she wanted to thank the Commission for their generous \$2,500 donation and support to allow the team to get to the tournament in Louisiana. She introduced three team members, who presented the Commission with a plaque. She noted that Broward County did a proclamation for the Shetland All-Star Team, and that copies would be provided. She acknowledged the Coaches and noted that the regional banner would be hanging up at the field.

JOHN HALL, 6421 French Angel Terrace, congratulated the new Mayor and Vice Mayor. He said that he read an article on MargateNews.net that spoke about priorities of the Commission, which he felt was wrong. He stated that the people were entitled to know the priorities. He said that when elected, the people were told that the Commission wanted to make Margate a better place to live, to drive through, to open and run a business. He felt that the City needed to do that by enforcing the rules, policies and standards that were set in Margate for years. He mentioned the Palm Trees that were previously obtained with a Federal Grant of \$4,500; however, they were not trimmed in years. He added that the medians along State Road 7 where nothing was maintained. He felt that the property in the City needed to be maintained.

5) CITY MANAGER'S REPORT

CITY MANAGER DOUGLAS E. SMITH congratulated the incoming Mayor and Vice Mayor. He thanked Mayor Simone for her hard work and dedication to the City. He thanked Director of Parks and Recreation Mike Jones and Staff, Police and Fire Department support for the Veteran's Day event. He also thanked the Veterans that served the Country. He noted that this Friday was the TD Bank Change event, which would support the Homeless Outreach Program through the Police Department. He said that there would be a check presentation later in the day at City Hall. He stated that Movies in the Park was showing Tomorrowland on Saturday night. He mentioned the Dr. Martin Luther King Jr. event, which was for the installation of a Butterfly Garden at Southgate Park. He said that he would continue to see what opportunities there would be to seek an art component. He explained that the City planned to reach out to areas stores for support of that event, as well as soliciting for volunteers among Staff,

Commission and residents. He added that the City would also be encouraging others in the community to do service projects that day and to let the City know about them for future recognition. City Manager Smith explained that for the new City Newsletter, a naming contest was held. He said that over 50 name submissions were received and City Staff selected the name, "Margate Matters." He recognized the submitter of that name as Mayor Simone. He stated that the City would be creating a graphic design for that name, which would be implemented after the first of the year. He noted that in the updates provided to the Commission today, there was section included for development updates. He stated that the Toscana Villa project should be ready for residents to move into by the end of the year. He said that there would be a workshop for the discussion of commercial vehicles in residential areas on December 9, 2015. He stated that the County passed an ordinance regarding a civil citation process for misdemeanor Marijuana possession. He explained that it was not a mandatory process and was set up at the discretion of an officer. He added that the Cities had the option to opt out, which could be discussed during a workshop.

VICE MAYOR RUZZANO asked whether the Cities would have to provide a Recovery Program.

CITY MANAGER SMITH said that he was not sure if the City had to provide it, but that there were dollar fines that applied for the first several offenses, or there was the option of community service or to voluntarily participate in a drug treatment or educational program. He was not certain as to what the City's role would be in providing those aspects and whether or not it was a requirement of the ordinance.

VICE MAYOR RUZZANO asked whether any of the proceeds or violation fees would go towards the City.

CITY ATTORNEY EUGENE STEINFELD said not that he was aware of.

A motion was made by Commissioner Bryan, seconded by Commissioner Peerman, that this Resolution be approved.

NORA RUPERT, Broward County School Board Representative, thanked the Commission for bringing forth the resolution. She said that she fought very hard for changes at Coconut Creek High School, which helped get her elected in 2010. She said that the children of North Lauderdale, Coconut Creek and Margate are bound for Coconut Creek High School, and that the school needed help. She said that a Magnet Program would afford an opportunity for all students. She explained that the Creek Technical Academy would be a vigorous program designed after the successful Atlantic Technical High School. She said that the academy would offer 27 CDE Programs, 27 CDE choices for dual enrollment and 10 Career Technical Academy Programs with Career Clusters in Business Management and Administration, Health Sciences, Information Technology and Transportation. She noted that the Health Science Program would have Allied Health Assistant, EKG Technician, Health Unit Coordinator and the first Veterinary Assistant Program. She stated that parents and community members were going around with petitions to support this program. She noted that anybody wishing to comment could go to BrowardSchools.com, which she encouraged because she was only one vote out of nine.

COMMISSIONER BRYAN thanked Ms. Rupert for attending the meeting. She noted that she and Ms. Rupert attended the Zone meeting on Monday. She added that she was a member of the SAC Committee for the students. She said that the students, parents and faculty were very excited and Coconut Creek was moving forward.

VICE MAYOR RUZZANO applauded Ms. Rupert for her work, and she asked when it would open if passed.

MS. RUPERT said that it would be opening next school year, 2016-2017, and that the Veterinary Assistant Program would start; however, the animal labs would take two years. She mentioned that bond money was being received to renovate the STEM Program. She noted that the transportation back and forth would also be coordinated between Atlantic Tech.

VICE MAYOR RUZZANO asked whether the bond money was earmarked or could it be spent.

MS. RUPERT said that some of the money was already earmarked for STEM Lab improvement, which was why she was pushing the Magnet Program because the labs were already being extended. She noted that it cost several hundred thousand dollars to

do a Veterinary Lab. She said that the curriculum would begin this fall and in two years the animals would come. She stated that it would create an opportunity for all of northern Broward County, because there were only two other Veterinary Programs; in West Broward and in South Plantation.

RICK RICCARDI, 4829 South Hemingway Circle, asked what the opposition was and why would it not pass.

MS. RUPERT said that everything was political, and finances were a part of it; however, if putting something in a district, another district might not be in agreement. She suggested looking at the boundary proposals, and that the community did need to get behind this program. She noted that it was considered a low performing school, which was not serving the children.

MAYOR SIMONE stated that some people did not like change and change was sometimes difficult.

COMMISSIONER PEERMAN thanked Ms. Rupert for representing Margate Schools. She believed a name change was needed for a long time. She said that it was massively important for the community to get behind this high school, or it could easily be overlooked and bypassed. She felt that the school needed the City Officials to speak for the high school.

COMMISSIONER TALERICO stated that Ms. Rupert was fighting tirelessly for the community and the students. He asked that she let the Commission know if she needed anything.
