A RESOLUTION OF THE CITY OF MARGATE, FLORIDA, (1) 2016 AMENDMENT TO INTERLOCAL APPROVING AGREEMENT BETWEEN BROWARD COUNTY AND MARGATE PROVIDING FOR DIVISION AND DISTRIBUTION OF THE PROCEEDS OF THE LOCAL OPTION GAS TAX IMPOSED BY THE BROWARD COUNTY LOCAL OPTION GAS TAX THE 2016 AMENDMENT TO THE ORDINANCE; (2)INTERLOCAL AGREEMENT BETWEEN BROWARD COUNTY AND THE CITY OF MARGATE PROVIDING FOR DIVISION DISTRIBUTION OF THE PROCEEDS FROM THE AND BROWARD COUNTY ADDITIONAL LOCAL OPTION GAS TAX ON MOTOR FUEL ORDINANCE; AND (3) 2016 AMENDMENT ΤO INTERLOCAL AGREEMENT BETWEEN BROWARD COUNTY AND MARGATE PROVIDING FOR DIVISION AND DISTRIBUTION OF THE PROCEEDS FROM THE BROWARD COUNTY FIFTH CENT ADDITIONAL LOCAL OPTION GAS TAX ON MOTOR FUEL FOR TRANSIT; PROVIDING FOR UPDATED POPULATION FIGURES.

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

SECTION 1: That the City Commission of the City of Margate, Florida, hereby approves (1) 2016 Amendment to the Interlocal Agreement between Broward County and Margate providing for Division and Distribution of the Proceeds of the Local Option Gas Tax Imposed by the Broward County Local Option Gas Tax Ordinance; and (2) 2016 Amendment to the Interlocal Agreements with Broward County providing for Division and Distribution of the Proceeds from the Broward County Additional Local Option Gas Tax on Motor Fuel Ordinance; and (3) 2016 Amendment to the Interlocal Agreement between Broward County and Margate providing for Division and Distribution of the Proceeds from the Broward County Fifth Cent Additional Local Option Gas Tax on Motor Fuel for Transit, with the percentage share adjusted for each city based on updated population figures.

SECTION 2: That the Mayor and City Manager are hereby authorized and directed to execute said amendments on behalf of the City of Margate, copies of which are attached and made a part of this Resolution. <u>SECTION 3:</u> That this Resolution shall become effective immediately upon its passage.
