ORDINANCE NO. 2014-9

AN ORDINANCE OF THE CITY OF MARGATE, FLORIDA, PROVIDING FOR AUTHORIZATION OF PURCHASES AND BID AWARDS BY THE CITY MANAGER; PROVIDING FOR APPROVAL CONTRACTS BYCOMMISSION; THE CITY PROVIDING FOR NOTIFICATION; PROVIDING SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Section 4.10 Contracts and 4.11 Purchases and bid awards, of the Charter of the City of Margate was amended by referendum, approved by the voters of the City of Margate, in the general election of November 4, 2014; and

WHEREAS, the City Commission of the City of Margate desires to provide for purchases and bid awards that may be approved by the City Manager and contracts that require Commission approval,

NOW THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

- SECTION 1: The City Manager may authorize purchases and bid awards on behalf of the City when individual expenditures do not exceed \$50,000.
- $\underline{\text{SECTION 2:}}$ All contracts that exceed \$50,000 must be approved by the City Commission.
- $\underline{\text{SECTION 3:}}$ For expenditures above \$25,000 and not exceeding \$50,000, notification of said expenditures shall be made to the City Commission.
- SECTION 4: All ordinances or parts of ordinances in conflict herewith are and the same is hereby repealed to the extent of such conflict.
- SECTION 5: If any section, sentence, clause, or phrase of this ordinance is held to be invalid or unconstitutional
