5 AN ORDINANCE OF THE CITY OF MARGATE,  
6 FLORIDA, PROVIDING FOR AUTHORIZATION OF  
7 PURCHASES AND BID AWARDS BY THE CITY  
8 MANAGER; PROVIDING FOR APPROVAL OF  
9 CONTRACTS BY THE CITY COMMISSION;  
10 PROVIDING FOR NOTIFICATION; PROVIDING  
11 FOR SEVERABILITY; PROVIDING FOR AN  
12 EFFECTIVE DATE.

15 WHEREAS, Section 4.10 Contracts and 4.11 Purchases and  
16 bid awards, of the Charter of the City of Margate was  
17 amended by referendum, approved by the voters of the City of  
18 Margate, in the general election of November 4, 2014; and  
19

20 WHEREAS, the City Commission of the City of Margate  
21 desires to provide for purchases and bid awards that may be  
22 approved by the City Manager and contracts that require  
23 Commission approval,  
24

25 NOW THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF  
26 THE CITY OF MARGATE, FLORIDA:  
27

28 SECTION 1: The City Manager may authorize purchases and  
29 bid awards on behalf of the City when individual  
30 expenditures do not exceed \$50,000.  
31

32 SECTION 2: All contracts that exceed \$50,000 must be  
33 approved by the City Commission.  
34

35 SECTION 3: For expenditures above \$25,000 and not  
36 exceeding \$50,000, notification of said expenditures shall  
37 be made to the City Commission.

39 SECTION 4: All ordinances or parts of ordinances in  
40 conflict herewith are and the same is hereby repealed to the  
41 extent of such conflict.

43 SECTION 5: If any section, sentence, clause, or phrase  
44 of this ordinance is held to be invalid or unconstitutional


by a court of competent jurisdiction, then said holding shall in no way affect the validity of the remaining portions of this ordinance.

SECTION 6: This ordinance shall become effective immediately upon adoption at its second reading.
