

**TASK ORDER  
BETWEEN**

**MARGATE COMMUNITY REDEVELOPMENT AGENCY**

**SALTZ MICHELSON ARCHITECTS, INC.**

This Architectural Services Task Order is entered into this \_\_\_\_ day of \_\_\_\_\_, 2016 by and between the MARGATE COMMUNITY REDEVELOPMENT AGENCY, hereinafter referred to as "CRA" and SALTZ MICHELSON ARCHITECTS, INC., hereinafter referred to as "CONTRACTOR".

**W I T N E S S E T H:**

WHEREAS, the CRA and the CONTRACTOR previously entered into an Agreement for General Architectural Services dated February 10, 2016 (the "Original Agreement"); and

WHEREAS, the CRA and the CONTRACTOR are authorized to enter into Task Orders in order to provide for additional services to be provided by the CONTRACTOR for the CRA, pursuant to the Original Agreement; and

WHEREAS, the CRA and the CONTRACTOR desire to enter into this Task Order in order for the CONTRACTOR to provide additional services pursuant to the Original Agreement, except as modified herein;

NOW, THEREFORE, in consideration of the mutual covenants and promises herein contained, the CRA and the CONTRACTOR agree as follows:

1. The "WHEREAS" clauses recited above are hereby incorporated herein by reference.
2. The CRA authorizes the CONTRACTOR to perform additional services as provided in this Task Order for the following CRA Project:

**Margate Sports Field, Covered Play Structure and Restroom Building  
Margate Sports Park, Margate, Florida**

3. The Scope of Services for the Project, as provided in the Original Agreement, is hereby amended in order to authorize the CONTRACTOR to provide the Scope of Services as described on Exhibit "A", to this Task Order, which is attached hereto and incorporated herein by reference.

4. The Budget for the Project as stated in the Original Agreement is hereby amended to reflect the adjustments indicated on Exhibit "A" to this Task Order, which is attached hereto and incorporated herein by reference. The total budget for this assignment shall not exceed: One Hundred Thirty-Seven Thousand Nine Hundred Dollars (\$137,900.00). Payments shall be disbursed as provided for in the Original Agreement, and as further outlined in Section IV of Exhibit "A" to this Task Order.

5. The Completion Date for the Project as stated in the Original Agreement is hereby amended to provide for the CONSULTANT to complete the Scope of Services described in Exhibit "A" to this Task Order no later than two hundred seventy (270) days (pre-construction) and an additional two hundred seventy (270) days (construction period) following the issuance of the Notice to Proceed, as more particularly described in Exhibit "B". This Task Order may be extended up to an additional sixty (60) days subject to a written amendment to this Agreement executed by the Chair of the MCRA. Extensions beyond sixty (60) days require approval by the MCRA Board.

6. This Task Order is approved contingent upon the CRA's acceptance of and satisfaction with the completion of the services rendered in the previous phase (if any) or as encompassed in the Original Agreement, as may have been amended by any prior Task Orders entered into between the CRA and the CONTRACTOR. If the CRA, in its sole discretion, is unsatisfied with the services provided in a previous phase, or prior Task Order, the CRA may terminate the Original Agreement without incurring any further liability.

7. The CONTRACTOR may not commence work on any Task Order, including this Task Order, approved by the CRA, without a further notice to proceed issued in writing by the CRA Executive Director, or her authorized representative.

8. The Original Agreement, as may have been modified by prior Task Orders, and except as modified herein, shall remain in full force and effect.
