A RESOLUTION OF THE CITY OF MARGATE, FLORIDA, APPROVING THE ACQUISITION OF MOBILE PRINTERS WITH ANCILLARY EQUIPMENT, FROM CDW-G, UTILIZING FUNDS FROM THE LAW ENFORCEMENT TRUST FUND, IN AN AMOUNT NOT TO EXCEED \$29,000.

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

**SECTION 1:** That the City Commission of the City of Margate, Florida approves the acquisition of mobile printers with ancillary equipment, from CDW-G, utilizing funds from the Law Enforcement Trust Fund, in an amount not to exceed \$29,000.

**SECTION 2:** That the acquisition is deemed to be in the best interest of the City of Margate.

**SECTION 3:** The Chief of Police recommends the expenditure of an amount not to exceed \$29,000 in State Law Enforcement Trust Funds ("LETFS") to acquire the specialized equipment (mobile printers with ancillary equipment) from CDW-G.

**SECTION 4:** The Chief of Police certifies that the expenditure of an amount not to exceed \$29,000 in LETFS to acquire the specialized equipment (mobile printers with ancillary equipment) from CDW-G complies with Section 932.7055, Florida Statutes, in that the funds will be used for an appropriate law enforcement purpose.

**SECTION 5:** The Chief of Police certifies that the expenditure of an amount not to exceed \$29,000 in LETFS to acquire the specialized equipment (mobile printers with ancillary equipment) from CDW-G complies with Section 932.7055, Florida Statutes, in that the funds are not being used as a normal source of revenue for the Police Department.

**SECTION 6:** The Chief of Police certifies that the expenditure of an amount not to exceed \$29,000 in LETFS to acquire the specialized equipment (mobile printers with ancillary equipment) from CDW-G complies with Section 932.7055, Florida Statutes, in that the funds were not considered in the adoption and approval of the Police Department budget.

**SECTION 7:** That the Mayor and City Manager are authorized and directed to execute a contract for the above acquisition, or administration is authorized to issue a purchase order for same.

**SECTION 8:** That this Resolution shall become effective immediately upon its passage.
