17	<b>SECTION 1</b> : That the Code of Ordinances of the City of		
18	Margate, Florida, Chapter 2 Administration, Article I - In		
19	General, Section 20 City logo and slogan, shall be created to		
20	read as follows <sup>1</sup> :		
21	Sec. 2-20. Prohibition on use of city logo and slogan.		
22	No person or entity may use or display the city's logo or		
23	slogan except the city and businesses directly affiliated with		
24	the city, such as the Community Redevelopment Agency and the		
25	Northwest Focal Point Center, as well as those entities having a		
26	sponsorship relationship with the city, such as city sponsored		
27	sports leagues. This section shall be effective and apply		
28	retroactively, and therefore, any person or entity currently		
29	using the City's logo or slogan must immediately cease such use.

Reserved. 4 All ordinances or parts of ordinances in SECTION 2: 5 conflict herewith are repealed to the extent of such conflict. 6 If any section, sentence, clause, or phrase SECTION 3: of this Ordinance is held to be invalid or unconstitutional by a 7 8 court of competent jurisdiction, then said holding shall in no 9 way affect the validity of the remaining portions of this 10 Ordinance. 11 It is the intention of the City Commission SECTION 4: that the provisions of this Ordinance shall become and be made a 12 13 part of the City of Margate Code, and that the sections of this 14 Ordinance may be renumbered or relettered and the word "ordinance" may be changed to "section", "article" or such other 15 16 appropriate word or phrase in order to accomplish such 17 intentions. 18 This Ordinance shall become effective SECTION 5:
