AN ORDINANCE OF THE CITY OF MARGATE, FLORIDA,

CREATING CHAPTER 2 ADMINSTRATION; ARTICLE I IN

GENERAL; SECTION 20 PROHIBITION ON USE OF CITY LOGO AND SLOGAN; PROVIDING FOR REPEAL; PROVIDING

17 <u>SECTION 1</u>: That the Code of Ordinances of the City of
18 Margate, Florida, Chapter 2 Administration, Article I - In
19 General, Section 20 City logo and slogan, shall be created to
20 read as follows¹:

Sec. 2-20. Prohibition on use of city logo and slogan.

No person or entity may use or display the city's logo or slogan except the city and businesses directly affiliated with the city, such as the Community Redevelopment Agency and the Northwest Focal Point Center, as well as those entities having a sponsorship relationship with the city, such as city sponsored sports leagues. This section shall be effective and apply retroactively, and therefore, any person or entity currently using the City's logo or slogan must immediately cease such use.

Words in struck through text are deletions from existing text, underscored words are additions to existing text, and shaded text reflect changes between First and Second Readings.

- 1 A violation of this section shall be punishable as provided in 2 Sections 1-8, 1-8.1 and 1-8.2 of the Code.
- 3 Secs. 2-201-2-24. Reserved.

- **SECTION 2:** All ordinances or parts of ordinances in conflict herewith are repealed to the extent of such conflict.
- SECTION 3: If any section, sentence, clause, or phrase of this Ordinance is held to be invalid or unconstitutional by a court of competent jurisdiction, then said holding shall in no way affect the validity of the remaining portions of this Ordinance.
- SECTION 4: It is the intention of the City Commission that the provisions of this Ordinance shall become and be made a part of the City of Margate Code, and that the sections of this Ordinance may be renumbered or relettered and the word "ordinance" may be changed to "section", "article" or such other appropriate word or phrase in order to accomplish such intentions.
- **SECTION** 5: This Ordinance shall become effective immediately upon adoption following second reading.
