AN ORDINANCE OF THE CITY OF MARGATE, FLORIDA, AMENDING CHAPTER 39 - WATER AND SEWERS - DEPARTMENT OF ENVIRONMENTAL AND ENGINEERING SERVICES, ARTICLE VIII - CROSS CONNECTION CONTROL / BACKFLOW PREVENTION, SECTIONS 39-105 AND 39-108; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

SECTION 1: CHAPTER 39 - WATER AND SEWERS - DEPARTMENT OF ENVIRONMENTAL AND ENGINEERING SERVICES, ARTICLE VIII - CROSS CONNECTION CONTROL / BACKFLOW PREVENTION, is hereby amended to read as follows¹:

Section 39-105. - Definitions

(t) Service connection point shall mean the location on a service connection where the water purveyor loses jurisdiction and sanitary control over the water at its point of delivery to customer systems. ~~Loss of jurisdiction and sanitary control occurs at the water meter. The dual check, if present, or water meter if no dual check is present, shall be the final point of water purveyor jurisdiction and sanitary control.~~

1 Section 39-108. - Customer responsibilities

2 (a) The customer shall continually maintain the backflow
3 prevention assembly~~or dual check~~ required by this article.

6 remain as codified.]

8 **SECTION 2:** All ordinances or parts of ordinances in
9 conflict herewith are repealed to the extent of such conflict.
10

11 **SECTION 3:** If any section, sentence, clause, or phrase
12 of this Ordinance is held to be invalid or unconstitutional by
13 a court of competent jurisdiction, then said holding shall in
14 no way affect the validity of the remaining portions of this
15 Ordinance.

17 **SECTION 4:** It is the intention of the City Commission
18 that the provisions of this Ordinance shall become and be made
19 a part of the City of Margate Code, and that the sections of
20 this Ordinance may be renumbered or relettered and the word
21 "ordinance" may be changed to "section", "article" or such
22 other appropriate word or phrase in order to accomplish such
23 intentions.

25 **SECTION 5:** This Ordinance shall become effective
26 immediately upon adoption at its second reading.
