RE: Waterfront Days - Date Amendment

Decision Makers:

The Margate Waterfront Foundation respectfully requests a date change for our kickoff Waterfront Days fundraiser. We are asking the board allow the organization to abandon the originally scheduled dates of November 10-20 and to approve a date change of January 26, 2017 to February 5, 2017 with move-in/move-out dates of January 23rd and February 8th. Additionally, The Foundation would submit a new site plan for the event upon approval of said date amendment.

In light of potential conflicts with an organization (St. Vincent Church) that had yet to submit an application for a similar event, the Foundation found it in the best interest of the community to abandon previous dates and set new ones. If not, two carnivals would potentially run back-to-back and result in the diminished efforts of both. To this end, The Margate Waterfront Foundation was the third non-profit organization to apply for such an event in 2016.

Whereas the CRA (Community Redevelopment Agency) allows the date amendment, the CRA would enable St. Vincent Church - sponsors of the largest event of its kind in Margate - to avoid having to submit a special exception, as the organization would be the 5th to apply for an event restricted by CRA policy to four times a year.

Additionally, The Foundation no longer requires the use of the City of Margate stage, but continues to seek the waiving of land use fees.

Whereas monies raised by the Foundation are to fund its mission on Margate waterways, monies used to pay land use fees would otherwise go directly into the community.

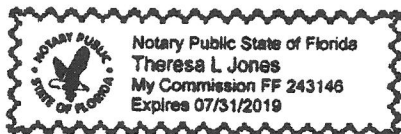
