FUTURE LAND USE ELEMENT ELEMENT ORDER TO INCREASE THERESERVATION OF DEVELOPABLE RIGHTS WITHIN THE ORIENTED CORRIDOR BOUNDARY; PROVIDING FOR REPEAL; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

SECTION 1: The Code of the City of Margate, Florida, Appendix B, Element I. Future Land Use is hereby amended to increase the reservation of developable rights within the Transit Oriented Corridor Boundary, as attached hereto and made a part of this ordinance.

SECTION 2: All ordinances or parts of ordinances in conflict herewith are and the same is hereby repealed to the extent of such conflict.

SECTION 3: If any section, sentence, clause, or phrase of this ordinance is held to be invalid or unconstitutional by a court of competent jurisdiction, then said holding shall in no way affect the validity of the remaining portions of this ordinance.
