*THE MEETING RECONVENED FOLLOWING A BRIEF RECESS.*

## 2) COMMISSION COMMENTS

*COMMISSIONER SIMONE explained that the Police Department would be enforcing the existing law concerning the lighting use of illegal fireworks. She said that anything that explodes or propels into the air was illegal to buy, sell or use. She clarified that the use of illegal fireworks was a first degree misdemeanor punishable by up to a year in jail and a \$1,000 fine. She announced that the Veteran's Day ceremony was Friday, November 11th at 10:30 AM at Veteran's Park. She added that Margate Under The Moon was scheduled for November 12th and Movies in the Park was scheduled for November 19th. She noted that the movie was Finding Dory. She stated that it was fall back time for the clocks and reminded everyone to set their clocks back one hour on Saturday night. Commissioner Simone noted that some residents were not receiving the Margate Matters in the mail. She explained that residents could sign up to have information sent electronically from the City's website for E-news. She expressed concerns regarding the Dog Park pertaining*

to the cost, location and design. She stated that the development of the park was at 67 percent and she did not know if the City should stop and re-evaluate it or continue to go forward. She explained that the cost kept fluctuating and increasing, and that the residents of Paradise Gardens 3 were not happy with the location. She said that it might be possible to redesign the park into a single park and entranceway, rather than two in an attempt to keep the cost down. She congratulated Commissioner Talerico and Vice Mayor Bryan on their retirement and thanked them for their service to the City.

COMMISSIONER PEERMAN said that a team was already put together for the Golf Tournament and she questioned how much sponsorship cost for a hole.

NORTHWEST FOCAL POINT SENIOR CENTER (NWFPSC) DIRECTOR KARIN DIAZ explained that there were different levels of sponsorship. She stated that the smallest sponsorship was \$500 for the whole package of four people playing and participating in the dinner.

COMMISSIONER PEERMAN asked whether a hole could be sponsored.

DIRECTOR DIAZ believed that could be done; however, she did not have the price list with her. She said that a hole could be sponsored and there would be a flag placed at the hole with the name of the sponsor.

COMMISSIONER PEERMAN wanted to find out about sponsoring two holes; one in the name of Commissioner Talerico and one in the name of Vice Mayor Bryan. She stated that the money could be taken from the Resident Project Fund if consensus was received.

DIRECTOR DIAZ believed it cost approximately \$100 or \$150, but she was not certain.

CONSENSUS was given and all agreed 5-0.

COMMISSIONER PEERMAN stated that Saturday would have been Margate Community Emergency Response Team (CERT) Family Fun Day when it was done at Firefighters Park, which was now changed to the Safety Festival. She noted that last year the Commission made a donation from the Resident Project Fund to purchase bicycles as prizes for giveaways at the event. She suggested taking \$250 from the Resident Project Fund for the CERT to buy bicycles again this year. She asked for consensus.

CONSENSUS was taken and all agreed 5-0.

COMMISSIONER PEERMAN thanked everyone for the excellent Fall Festival. She wished the retiring Commissioners well.

COMMISSIONER TALERICO spoke about the many things that had been done in the City during his tenure with the City. He said that the Sign Ordinance was improved to allow monument signs and a Transportation Program was started to allow transportation for Senior citizens. He said that he named the first City Newsletter, which was the Margate Messenger. He stated that an Annual Food Drive was started for the needy. He said that minimum lighting standards were approved to improve lighting in shopping centers. He added that the Pension Plan for K-9's was started, and the Kiwanis Shop with a Cop began many years ago. He said that Calypso Cove was built and the Community Redevelopment Agency (CRA) began. He said that the National Accreditation of the Police Department was done and there was an increased citizen involvement with Margate Community College. He stated that roadside memorials were now provided and

*elections were changed to be held in November to save taxpayer money. He stated that a bond issue was passed at 80 percent to repair the bridges, sidewalks and roads. He noted that he served on every City Board in the City. He thanked everyone in the City and wished everybody a happy holiday.*

*VICE MAYOR BRYAN congratulated Commissioner Talerico and noted that she would be present for two more City Commission meetings. She stated that the Dog Park was to be located in her Paradise Gardens 3 neighborhood and she felt that was not the right place for it. She reminded everyone to come to the Veteran's Day celebration and noted that the City would be giving cards to the Veterans from Margate Elementary School and Liberty Elementary School. She stated that the groundbreaking of Rising Tide Car Wash was to take place on Wednesday, November 16th, which was an organization that only employed those individuals with Autism. She said that her neighbor had a complaint which was forwarded to the City Manager regarding a light on Rock Island and 17th Street. She added that she had a fun time at the Mayor's Gala two weeks ago.*

*MAYOR RUZZANO said that Commissioner Talerico would be missed. He said that the Mayor's Gala was a great event. He noted that a Margate Veteran had attended and received a plaque and a tribute. He stated that the Fall Festival was awesome except for the rain. He commended Parks and Recreation Director Mike Jones for the event. He stated that he received the drawings for the Dog Park and said that the cost was higher than when he built the Tamarac Dog Park. He said that there were no undergrounds and it needed to be looked at again. He felt that the park was needed, but it should be reviewed by the new Commission. He thanked his baseball team that won 18-3 versus West Boca and remained undefeated. He also congratulated his daughter for receiving first place for cheerleading. He requested that Item 9A be moved to be heard after the City Manager's Report.*

*CITY ATTORNEY DOUGLAS R. GONZALES congratulated Commissioner Talerico. He thanked the Commission for the evaluations of the Charter Officers. He noted that all resolutions were on the Consent Agenda tonight, as requested by Commissioner Talerico. He thanked Commissioner Peerman for assisting him with the Florida League of Cities Policy Committee procedures and guiding him through the process. He said that he was extended an offer to be an Adjunct Professor at Nova Southeastern University teaching Criminal Law starting in the fall semester. He noted that it was an online course and appreciated the Commission's support. He noted that he had not received his car, which was approved in late April and was ordered in July when no 2016 vehicles were available. He said that the request was instead fulfilled by providing a 2017, but because the funds were not sufficient to purchase the 2017 model, the safety feature package was not included. He noted that due to that, the City chose not to purchase that vehicle. He explained that he was working with Public Works Director Sam May, who was able to find a 2016 that had the safety package, but also had two other packages that could not be removed. He said that he could either ask for additional funding for up to \$4,000 more than what was approved. He noted that the City Manager's vehicle was a 2017 model that cost more than his vehicle, and he explained that the additional \$2,000 was to pay the cost of the two additional packages. He stated that if the vehicle was sold already, he would order one; however, he would still need the additional monies. He asked for a consensus to allow Director May to find the 2016 vehicle that was available, or to order a 2017 model.*

*CONSENSUS was given and all agreed 5-0.*

*CITY CLERK JOSEPH J. KAVANAGH spoke about Commissioner Talerico's kind nature and how honorable and respectful he was. He noted that he always treated his*

*Staff members with great dignity and he wished him the best of luck. He reminded everyone that Tuesday, November 8th, was the National General Election and the City of Margate General Election. He noted that there were 16 polling places in the City of Margate, which would be open from 7:00 AM to 7:00 PM. He stated that additional information could be obtained on the Broward Supervisor of Elections website at [www.browardsoe.org](http://www.browardsoe.org).*

*MAYOR RUZZANO mentioned looking into having busses to transport residents to the polling places for the next election.*

*JOHN HALL, 6421 French Angel Terrace, thanked Commissioner Talerico for his long honorable service to the City.*

*ARLENE SCHWARTZ, former Mayor, noted that Commissioner Talerico was her son's Soccer Coach. She wished him the best of luck.*

## 5) CITY MANAGER'S REPORT

*CITY MANAGER DOUGLAS E. SMITH stated that the Relay for Life resolution would be provided at the next meeting; however, he received a request for promotion of the Cars for a Cure Relay for Life event to be held on December 3rd, 2016.*

*CONSENSUS was taken and all agreed 5-0.*

*CITY MANAGER SMITH mentioned upcoming road work of a new sewer connection on NW 24th Street beginning on Monday, November 7th. He noted that the road would be closed that Monday morning with appropriate detours being set up. He said they might be removed Thursday; however, they could remain until Friday, November 11th. He stated that there would be multiple avenues of communication going out regarding the Illegal fireworks, such as a utility bill insert for the end of October going into November. He added that it would be provided in the City Newsletter in the November and December editions, as well as on the website and on Channel 78 and Social Media. He noted that Channel 78 was up and running with successful meetings being broadcasted. He said that possibly at the next meeting, there would be an agreement coming before the Commission for supplemental Building Code service assistance. He explained that this type of firm helped with filling in additional support for positions in the Building Department. He stated that the final Site Plans were reviewed and approved for Arbor View Apartments at NW 31st Street and U.S. 441 intersection. He added that Floribbean Wholesale expansion was also approved for NW 17th Street. He noted that the Margate Basketball League currently had open registrations. He thanked the Staff involved with the Fall Festival, and thanked Commissioner Talerico for the opportunity of working with him and for his years of service.*

He mentioned having an event at the American Legion to provide dinner to those who did not have a family. He said that the request for the funds was to help hold the event because of low membership.*

*MAYOR RUZZANO noted that the cost to fund last year's event was \$2,500.*

MAYOR RUZZANO said that 500 retired military members were served with 400 being from Margate. He stated that he appreciated the great job the American Legion was doing. He noted that Mr. Delalla just took over the Presidency of the Baseball League and was doing a great job.
