





Dear Mr. Alan Ritz Thank you for allowing Weatherproofing Technologies, Inc. ("WTI") to provide you with a proposal for work at the above-referenced location.

SCOPE OF WORK (THE "WORK"):

- 1) Perform restoration to roof surface equal to approximately 3,500 sq. ft.
- 2) Power wash roof surface to remove all loose granules, dirt and grime from the roof.
- 3) Apply Geogard LO Base to the field membrane at the Tremco recommended rate of 2.5 gal per sq.
- 4) Set PermaFab fabric in the Geogard LO Base to all laps and work into the system as required.
- 5) Apply Geogard Finish Coat over the Base at the Tremco recommended rate of 1 gal per sq.
- 6) Customer is to supply area adjacent to the building for loading of the roof at the beginning of the project and at the conclusion of the project.
- 7) Customer is to supply area for dumpster during the project close to the building.
- 8) Customer is to supply a secure staging area adjacent roof level to be restored.
- 9) Roof restoration project is to be performed during normal working hours.
- 10) Tremco will provide a 12 year QA Warranty for the Restoration System
- 11) Check in and out with the customer on a daily basis.
- 12) Remove all debris from the roof on a daily basis.
- 13) Take before and after photos of all work performed.

Notes: Any necessary permit fees will be the responsibility of the customer and are not included in this proposal. WTI will apply for all permits and supply necessary information to corresponding Building Department. Permit fee is unknown until review of job by the local building department.
