ORDINANCE NO.

AN ORDINANCE OF THE CITY OF MARGATE, FLORIDA, AMENDING APPENDIX-A ARTICLE III GENERAL PROVISIONS, SECTION 3.14. CONSTRUCTION OF FENCES, WALLS AND/OR HEDGES; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

SECTION 1: The Code of Ordinances of the City of Margate, Florida, Appendix-A Zoning, Article III General Provisions, Section 3.14 Construction of fences, walls and/or hedges, is hereby amended to read as follows1:

Sec. 3.14. - Construction of fences, walls and/or hedges.

The following shall govern with regard to the construction of fences, walls and/or hedges within the City of Margate:

(14) (A)

For all plots of one-family and two-family dwellings, no fences or walls shall be erected or maintained within any front and corner yards. For all plots of single-family detached dwellings and duplex detached dwellings,

1 a fence may be erected and maintained as required by 2 code along any side and rear plot lines or within the 3 required yard setbacks to a height not exceeding six (6) feet. For corner lots defined per section 2.2 as 4 5 having two front yards, the front yard abutting the rear yard shall be treated as a street side yard for 6 7 the purposes of erecting a fence. 8 9 10 11 12 [Note to Municipal Code: The rest of this section shall 13 remain as codified.] 14 15 16 **SECTION 2:** All ordinances or parts of ordinances in conflict herewith are and the same is hereby repealed to 17 the extent of such conflict. 18 19 20 SECTION 3: If any section, sentence, clause, or 21 phrase of this ordinance is held to be invalid or unconstitutional by a court of competent jurisdiction, then 22 said holding shall in no way affect the validity of the 23 24 remaining portions of this ordinance. 25 26 SECTION 4: It is the intention of the City 27 Commission that the provisions of this ordinance shall become and be made a part of the City of Margate Code, and that the 28 29 sections of this ordinance may be renumbered or relettered and the word "ordinance" may be changed to "section", 30 "article" or such other appropriate word or phrase in order 31 to accomplish such intentions. 32 33 34 SECTION 5: This ordinance shall become effective immediately upon adoption at its second reading. 35 36 37 PASSED ON FIRST READING THIS DAY OF 2017.
