AN ORDINANCE OF THE CITY OF MARGATE, FLORIDA, CHAPTER 2 ADMINISTRATION, AMENDING ARTICLE IV - BOARDS, COMMITTEES, ETC., DIVISION 2 - BOARD OF ADJUSTMENT, SECTION 2-76 AND DIVISION 3- PLANNING AND ZONING BOARD, SECTION 2-86; PROVIDING FOR APPOINTMENTS FOR A ONE YEAR PERIOD CONSISTENT WITH SECTION 2-73; PROVIDING FOR REPEAL; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

SECTION 1: The Code of Ordinances of the City of Margate, Florida, Chapter 2. Administration, Article IV, Division 2-Board of Adjustment, Section 2-76, is hereby amended to read as follows1:

Sec. 2-76. - Created; appointment; terms; officers; advisors.

A <u>B</u>board of <u>A</u>adjustment for the <u>C</u>eity is hereby created and established consisting of five (5)—members who shall be qualified as <u>B</u>board members as provided by law. The <u>B</u>board members shall be appointed by the <u>C</u>eity <u>C</u>eommission and shall serve without compensation and at the pleasure of said <u>C</u>eity <u>C</u>eommission. All appointments shall be for a <u>onetwo</u>—year period. The members of said <u>B</u>board shall elect a chairperson, a vice-chairperson, and a secretary from its membership. The <u>C</u>eity <u>M</u>manager, <u>C</u>eity building inspector, <u>C</u>eity <u>A</u>attorney and such other officers and officials of the <u>C</u>eity as the <u>B</u>board may require shall be considered as

advisors to the \underline{Ce} ity \underline{Bb} oard of \underline{Aa} djustment and may be called upon from time to time to meet with said \underline{Bb} oard.

SECTION 2: The Code of Ordinances of the City of Margate, Florida, Chapter 2. Administration, Division 3-Planning and Zoning Board, Section 2-86, is hereby amended

Sec. 2-86. - Creation; appointment; terms; officers; advisors.

to read as follows:

A <u>Ceity Pp</u>lanning and <u>Zzoning Bb</u>oard for the City of Margate is hereby created and established, consisting of five (5)—members. The <u>said Bb</u>oard members shall be appointed by the <u>Ceity Ceommissioners</u>, and shall serve without compensation and at the pleasure of said <u>Ceity Ceommission</u>.

All appointments shall be for a onetwo-year period.

The members of the said \underline{Bb} oard shall elect a chairman, a vice chairman, and a secretary from its membership.

The <u>Ceity Mmanager</u>, <u>Ceity building inspector</u>, <u>Ceity Aattorney</u>, and such other officers and officials of the <u>Ceity as the Bboard may require</u>, shall be considered as advisors to the <u>Ceity Pplanning and Zzoning Bboard and may be called upon from time to time to meet with said Bboard.</u>

SECTION 3: All ordinances or parts of ordinances in conflict are repealed to the extent of such conflict.

<u>SECTION 4</u>: If any section, sentence, clause, or phrase of this Ordinance is held to be invalid or unconstitutional by a court of competent jurisdiction, then said holding shall in no way affect the validity of the remaining portions of this Ordinance.

SECTION 5: It is the intention of the City Commission that the provisions of this Ordinance shall become and be made a part of the City of Margate Code, and that the sections of this Ordinance may be renumbered or relettered and the word "ordinance" may be changed to "section", "article" or such other appropriate word or phrase in order to accomplish such intentions.

SECTION 6: This Ordinance shall become effective
immediately upon adoption at its second reading.
