AN ORDINANCE OF THE CITY OF MARGATE, FLORIDA, AMENDING CHAPTER 2 - ADMINISTRATION, ARTICLE IV. - BOARDS, COMMITTEES, ETC., DIVISION 2. BOARD OF ADJUSTMENT, SECTION 2-77. - WHEN MEETINGS TO BE HELD AND DIVISION 3. PLANNING AND ZONING BOARD, SECTION 2-82. - MEETINGS OF THE PLANNING AND ZONING BOARD AND BOARD OF ADJUSTMENT; PROVIDING FOR MEETINGS; PROVIDING FOR REPEAL; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

SECTION 1: The Code of Ordinances of the City of Margate, Florida, Chapter 2. Administration, Article IV, Division 2-Board of Adjustment, Section 2-77, is hereby amended to read as follows1:

Sec. 2-77. - When meetings to be held.

Meetings of the Board of Adjustment shall be held once per month unless canceled by the Chair for lack of agenda items. Meetings of the Bboard of Aadjustment may shall be held at the call of the Cehairman and at such other times as the Bboard may determine. The Bboard may, by the adoption of its own rules and regulations consistent with

the provisions of this division, establish a regular meeting night and rules for the calling of regular and special meetings of the <u>Bb</u>oard. <u>Meetings shall be held in the Commission Chambers of the City Hall of the City of Margate unless said chambers are unavailable.</u>

SECTION 2: The Code of Ordinances of the City of Margate, Florida, Chapter 2. Administration, Division 3-Planning and Zoning Board, Section 2-82, is hereby amended to read as follows:

Sec. 2-82. - Meetings of the Pplanning and \underline{Zz} oning \underline{Bb} oard and board of adjustment.

All regular meetings of the planning and zoning board of the city and the board of adjustment of the city shall be scheduled on the same evening of the month, in the chambers of the city hall of the City of Margate unless said chambers are unavailable. The board of adjustment shall not convene later then twenty (20) minutes subsequent to the time that the planning and zoning board adjourns. Meetings of the Planning and Zoning Board shall be held once per month unless canceled by the Chair for lack of agenda items. Meetings of the Planning and Zoning Board may be held at the call of the Chair and at such other times as the Board may determine. Meetings shall be held in the Commission Chambers of the City Hall of the City of Margate

SECTION 4: If any section, sentence, clause, or phrase of this Ordinance is held to be invalid or unconstitutional by a court of competent jurisdiction, ther said holding shall in no way affect the validity of the remaining portions of this Ordinance. SECTION 5: It is the intention of the City Commission that the provisions of this Ordinance shall become and be made a part of the City of Margate Code, and that the sections of this Ordinance may be renumbered or relettered and the word "ordinance" may be changed to "section", "article" or such other appropriate word or phrase in order to accomplish such intentions.
