SECTION 2: The Code of Ordinances of the City of Margate, Florida, Chapter 2. Administration, Division 3-Planning and Zoning Board, Section 2-82, is hereby amended to read as follows:

Sec. 2-82. - Meetings of the <u>P</u>planning and <u>Z</u>zoning <u>B</u>board and board of adjustment.

All regular meetings of the planning and zoning board of 14 the city and the board of adjustment of the city shall be 15 scheduled on the same evening of the month, in the chambers 16 17 of the city hall of the City of Margate unless said 18 chambers are unavailable. The board of adjustment shall not convene later then twenty (20) minutes subsequent to the 19 20 time that the planning and zoning board adjourns. Meetings 21 of the Planning and Zoning Board shall be held once per month unless canceled by the Chair for lack of agenda 22 23 items. Meetings of the Planning and Zoning Board may be held at the call of the Chair and at such other times as 24 25 the Board may determine. Meetings shall be held in the 26 Commission Chambers of the City Hall of the City of Margate unless said chambers are unavailable. The Board may, by the adoption of its own rules and regulations consistent with the provisions of this division, establish a regular meeting night and rules for the calling of regular and special meetings of the Board.

**SECTION 3**: All ordinances or parts of ordinances in conflict are repealed to the extent of such conflict.

<u>SECTION 4</u>: If any section, sentence, clause, or phrase of this Ordinance is held to be invalid or unconstitutional by a court of competent jurisdiction, then said holding shall in no way affect the validity of the remaining portions of this Ordinance.

<u>SECTION 5</u>: It is the intention of the City Commission that the provisions of this Ordinance shall become and be made a part of the City of Margate Code, and that the sections of this Ordinance may be renumbered or relettered and the word "ordinance" may be changed to "section", "article" or such other appropriate word or phrase in order to accomplish such intentions.

**SECTION 6:** This Ordinance shall become effective immediately upon adoption at its second reading.
