Self-Service 32 Storage. 33 (A) No building shall be located closer than thirty-five (35) feet to any trafficway having a right-of-way width of 34 eighty (80) feet or greater. This setback shall not apply to 35 accessory structures located in rear yards, and further shall 36 37 not apply to Holiday Springs Boulevard or any property with a TOC-C, TOC-G, or TOC-CC zoning designation. 38 39 40 ¹ CODING: Words in struck through text are deletions from existing 41 42 text, words in underscored text are additions to existing text, and 43 shaded text are changes between First and Second Readings.
