CALL TO ORDER

1) PUBLIC DISCUSSION

There was no Public Discussion.

2) MOTION(S)

A. ID 2017-483 MOTION: APPROVAL OF DEATH BENEFIT.

CHAIR JIM WILBUR explained that former Building Department retiree Fran Zeppetella passed away on June 6th, 2017. He noted that he received a letter from her husband and upon reviewing her file it was determined that her beneficiary was Joseph Zeppetella. He said that according to the Plan Document, which stated that the Fund prepaid for the year, the death benefit would be 12 months minus the 6 months she survived; therefore, the death benefit was half of what was paid in January. He noted that check number 2931 in the amount of \$1,130.40 was issued on January 19th, 2017; therefore, half of that was \$565.20.

A motion was made by Trustee Sudman, seconded by Trustee DiNatale, To grant a check for \$565.20 to the beneficiary. The motion carried by the following vote:

CHAIR JIM WILBUR noted that there were 3 invoices to pay. He stated that there was a Microfilming invoice for \$272.35 and an FRS invoice for payment for participating members.

CONSENSUS was given 5-0 to pay those invoices.

CHAIR WILBUR stated that the third invoice was the Attorney's invoice for \$515.73.

A motion was made by Secretary Chin-Kidd, seconded by Trustee Sudman, to pay the Attorney's invoice of \$515.73.
