A RESOLUTION OF THE CITY OF MARGATE, FLORIDA, APPROVING ACQUISITION OF MARKED AND UNMARKED VEHICLES AN EXISTING FLORIDA SHERIFF'S ASSOCIATION BID AWARD, AND APPROVING WAIVING OF BIDDING FOR ANCILLARY EQUIPMENT TO MAINTAIN STANDARIZATION WITH PRIOR ACQUISITIONS, IN AN AMOUNT NOT TO EXCEED \$51,200.00 PROVIDING FOR FUNDING FROM THE LAW ENFORCEMENT TRUST FUND; AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

SECTION 1: That the City Commission of the City of Margate, Florida approves the acquisition of marked and unmarked vehicles (fully equipped) utilizing an existing Florida Sheriff's Association bid award and approving waiving of bidding for ancillary equipment to maintain standardization with prior acquisitions, and providing for utilizing funds from the Law Enforcement Trust Fund, in an amount not to exceed \$51,200.

SECTION 2: That the acquisition is deemed to be in the best interest of the City of Margate.

SECTION 3: The Chief of Police recommends the expenditure of an amount not to exceed \$51,200 in State Law Enforcement Trust Funds ("LETFS") to acquire marked and unmarked fully equipped vehicles and ancillary equipment.

SECTION 4: The Chief of Police certifies that the expenditure of an amount not to exceed \$51,200 in LETFS to acquire marked and unmarked fully equipped vehicles and ancillary equipment complies with Section 932.7055, Florida Statutes, in that the funds will be used for an appropriate law enforcement purpose.

SECTION 5: The Chief of Police certifies that the expenditure of an amount not to exceed \$51,200 in LETFS to acquire marked and unmarked fully equipped vehicles and ancillary equipment complies with Section 932.7055, Florida Statutes, in that the funds are not being used as a normal source of revenue for the Police Department.

SECTION 6: The Chief of Police certifies that the expenditure of an amount not to exceed \$51,200 in LETFS to

acquire marked and unmarked fully equipped vehicles and ancillary equipment complies with Section 932.7055, Florida Statutes, in that the funds were not considered in the adoption and approval of the Police Department budget.

SECTION 7: That the Mayor and City Manager are authorized and directed to execute a contract for the above acquisition, or administration is authorized to issue a purchase order for same.

SECTION 8: That this Resolution shall become effective immediately upon its passage.
