Subject: Approval for DRC

PD recommendation for the safety and security of the upcoming Carnival Event is as follows:

FENCING:

First, we strongly recommend a fence be erected around the carnival area like has been the practice at previous carnivals. This step is to help provide one entry point for ingress and egress and prevent groups of individuals from running in and out of the event at different locations. Hildebrand Rides found this conducive to their business, as well and it allows them to require a minimal entry fee.

STAFFING:

These recommendations are for minimum staffing for safety and security purposes. The CRA can choose to harden the event's security further, if they desire. This recommendation is based on the event being fenced in. It does not include any coverage for traffic control or pedestrian crossing, for patrons that park across the street of the event.

Fridays, Saturdays, and Sundays: **5 Officers, 1 Supervisor**

6 PM to 30 minutes past closing time (TBD - Not Yet Approved) for shutting down the event and disbursing lingering crowds.

Monday thru Thursday: **4 Officers, 1 Supervisor**

6 PM to 30 minutes past closing time (TBD - Not Yet Approved) for shutting down the event and disbursing lingering crowds.

JUSTIFICATION:

Carnivals have the propensity to draw undesirable gangs and unruly crowds to the event. This has been occurring with increased frequency at Margate carnivals for the past couple of years, and has been experienced throughout the county at similar events. This is the first time Margate is permitting a carnival during a time when youth is out of school for the entire duration of the operational hours of the carnival. Last year, during a November carnival, we did not staff weekdays and on Thursday (Thanksgiving - no school), they experienced a very large crowd of youths and young adults and did not have the event staffed. Therefore, the PD is recommending that the carnival be staffed every night of carnival operation. There is no way to predict if there will be a problem and/or what night an incident could occur. This recommendation is in addition to our attempts to secure assistance from the Multi-Agency Gang Task Force (MAGTF), which may or may not be available during the holidays. Also, MAGTF will not commit to the entire event. The PD will attempt to secure MAGTF for as many dates as possible. Keeping officers over 30 minutes past closing time is to ensure safe departure of all patrons. We have found in the past that parents tend to drop youths off at the event and do not pick them up until sometimes hours after event closure.

COST:

During the Holiday Season, it is difficult to secure officers to voluntarily work when they are off-duty. December typically has an increase in demand for off-duty officers for holiday events, retail stores, and neighborhood safety. The month of December's off-duty details have already been posted and scheduled since the middle of November. This late request, coupled with the smaller pool of detail officers will require High Demand/Holiday Rates in order to fill them. This is because officers want to spend time with their families when they are off-duty during the holidays. Even at High Demand/Holiday Rates, we are not sure if we will be able to fill all the positions.

The total for the event as proposed will cost approximately \$22,404 (this amount is utilizing a time ending of 11PM during the week, and 12AM Friday, Saturday, and Sunday, per the recommendations of Mr. Pellecchia at the CRA meeting. See the below schedule).
