A RESOLUTION OF THE CITY OF MARGATE, FLORIDA, APPROVING WITH CONDITIONS A TEMPORARY USE PERMIT FOR THE MARGATE WATERFRONT FOUNDATION CARNIVAL, TO BE HELD AT 1000 N STATE ROAD 7, FROM DECEMBER 22 THROUGH DECEMBER 31, 2017; PROVIDING FOR EFFECTIVE DATE.

WHEREAS, On November 9, 2017 the Margate Community Redevelopment Agency granted permission to the Margate Waterfront Foundation to use their property located at 1000 N State Road 7 for a carnival. The carnival dates of operation are scheduled for December 22 - 31, 2017, event set-up is scheduled for December 19 - 21, 2017, and event breakdown is scheduled for January 1 - 3, 2018; and

WHEREAS, On November 21, 2017, the Margate Waterfront Foundation submitted a Temporary Use Permit (TUP) application; and

WHEREAS, The Margate Waterfront Foundation has requested that the carnival be permitted to operate until 12 midnight on Fridays, Saturdays, and New Year's Eve;

WHEREAS, Section 3.24 of the Margate Zoning Code provides that only the City Commission has the authority to approve a TUP application for a carnival, and only the City Commission has the authority to approve a TUP application for an event that operates beyond 10 P.M.;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

**SECTION 1:** The foregoing "WHEREAS" clauses are incorporated in and made a part of this Resolution.

**SECTION 2:** That the City Commission of the City of Margate, Florida, hereby approves with conditions a Temporary Use Permit (TUP) application granting permission to the Margate Waterfront Foundation to hold a carnival at 1000 N State Road 7 from December 22-31, 2017, with event set-up to take place December 19-21, 2017, and event breakdown to take place January 1-3, 2018; subject to the following conditions:

- 1) Provide a perimeter security fence for the carnival.
- 2) Obtain a building permit for the carnival, including said security fence.

- 3) Provide police detail for the event, not less than 5 officers and 1 supervisor on Fridays through Sundays; and not less than 4 officers and 1 supervisor on Mondays through Thursdays.
- 4) That the carnival shall be permitted to operate, including breakdown, until December 31, 2017.

**SECTION 3:** That all representations by the applicant are incorporated as part of the conditions for this Temporary Use Permit (TUP).

**SECTION 4:** That this resolution shall become effective immediately upon its passage.
