10 AN ORDINANCE OF THE CITY OF MARGATE,  
11 FLORIDA, AMENDING THE MARGATE CODE OF  
12 ORDINANCES TO CHANGE ALL REFERENCES TO  
13 "ECONOMIC DEVELOPMENT DEPARTMENT" TO THE  
14 "DEVELOPMENT SERVICES DEPARTMENT";  
15 PROVIDING FOR CODIFICATION, SEVERABILITY  
16 AND AN EFFECTIVE DATE.

19 WHEREAS, on May 16, 2012, the City Commission of the  
20 City of Margate approved Ordinance 2012-9 providing for  
21 creation of the Department of Economic Development and  
22 provided for the Director and responsibilities of the  
23 Department; and,

25 WHEREAS, the City Commission of the City of Margate  
26 desires to amend the name of the Department to the  
27 Development Services Department to be consistent with the  
28 duties of the Department; and  
29

30 WHEREAS, the amendment to the Development Services  
31 Department will be a name change only and will not alter  
32 the development review or approval processes.

34 NOW THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION  
35 OF THE CITY OF MARGATE, FLORIDA:  
36

37 SECTION 1: That all references in City Code to the  
38 Economic Development Department shall be amended to the  
39 Development Services Department.  
40

41 SECTION 2: That all ordinances or parts of ordinances  
42 in conflict herewith be and the same are hereby repealed  
43 to the extent of such conflict.  
44

45 SECTION 3: That if any section, sentence, clause, or  
46 phrase of this ordinance is held to be invalid or  
47 unconstitutional by a court of competent jurisdiction,

then said holding shall in no way affect the validity of the remaining portions of this ordinance.

SECTION 4: It is the intention of the City Commission that the provisions of this ordinance shall be implemented by the publisher of the City Code which is directed to change all references to Economic Development Department to Development Services Department so that the name change becomes and is made a part of the City of Margate Code.

SECTION 5: That this ordinance shall become effective immediately upon adoption at its second reading.
