SUBJECT: Purchase Request for Rifle Mounts and Rifle Boxes

Presently the Investigative Services Bureau (ISB) handles undercover surveillance operations as well as high-risk enforcement operations, all of which could occur during our workdays or being called into work at a moment's notice. In this day and age a tremendous concern is the safe security/housing of our firearms, to include our handguns and rifles while inside our vehicles. With that being said, I am respectfully requesting the purchase of eight trunk rifle mounts 19 Tuffy Security Products Tactical Lox-Boxes for ISB and administration personnel.

Rifle Trunk Mounts are currently being purchased from Strobes-R-Us, and are installed by Public Works. We are familiar with this product as we have been using it in trunk mount applications. The cost per trunk mount is \$227.50.

Tuffy Security Products Tactical Lox-Boxes comes with a Pushbutton lock and Key system. The dimensions of the boxes are 12"W x 40"L x 9"H. This box is capable of securing all issued firearms and other items. These tactical security lock boxes are also able to be easily transferred into any vehicle and securely attached to the inside of such vehicle using provided cable lock and padlock system. Special Enforcement Team Members tested these boxes with commonly used vehicles and there were no issues with them being placed into them. Additionally, these boxes are not permanently mounted, an installation of the boxes by Strobes-R-Us is included. Tactical Security Lock Boxes and Install Kits from Strobes-R-Us are \$481.80 each.




