SUBJECT: Special Response Team Gas Mask Replacement

I have been noticing visible signs of wear on all of the issued gas masks for the Special Response Team (SRT). The rubber is drying out and cracking, and the face shields are getting scratched to the point that visibility is being affected. Also, many of the elastic straps are becoming worn and frayed. The gas masks in service now were purchased in 2009 and have a warranty of five years from date of manufacture. I recommend we purchase replacement gas masks for each member of the team. The current price as of this date from SRT Supply is \$273.95 each on Florida Highway Patrol contract pricing. To equip the 18 operators with masks, filters and clear face shields will cost \$7,067.50 including shipping.
