A RESOLUTION OF THE CITY OF MARGATE, FLORIDA, AMENDING RESOLUTION 16-174 AND APPROVING THE SCHEDULE OF FEES AND CHARGES FOR PARKS AND RECREATION FACILITIES, PROGRAMS, SERVICES, AND EQUIPMENT PURSUANT TO SECTION 27-7 OF THE MARGATE CITY CODE; PROVIDING FOR MARGATE PUBLIC SCHOOLS TO HAVE A FREE, FOUR (4) HOUR RENTAL OF THE CALYPSO COVE AQUATICS FACILITY DURING OFF-SEASON HOURS SUBJECT TO FACILITY AND STAFFING AVAILABILITY; PROVIDING FOR AN EFFECTIVE DATE.

BE IT RESOLVED FOR THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

1. All City of Margate employees shall be charged at the resident rate.		
2. The following are exempt from the mobile stage fee structure: municipalities within Broward County, government entities within Broward County, and existing City of Margate sponsored sports leagues.		
3. <u>Margate public schools shall have a free, four(4) hour rental of the Calypso Cove Aquatics Facility during off-season hours, subject to facility and staffing availability.</u>		
4. <u>Waiving of any fee, besides the above mobile stage and Margate Public School exemptions, shall be approved by a motion of the City Commission.</u>		
5. Fees for facilities and services provided pursuant to a grant shall be determined based upon the applicable grant agreement.		

SECTION 2: All Resolutions or parts of Resolutions in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 3: This Resolution shall become effective this date.
