Mike Jones gave a brief overview of the grant request. He explained that the city has a 5-year plan capital improvement program which lists Southgate Park for renovations. He stated that the grant in the amount of \$200,000 will be used for improvements which include, renovating the courts, a new walking and fitness path, landscaping and irrigation improvements, a multipurpose field, lighting improvements, and support facilities which include fountains and benches. He believes that this project will score high for the grant and the City will be awarded the \$200,000. He also mentioned that this is the same grant that the City was awarded last year for the improvements at Fire Fighters Park.

Andrew Pinney stated that the overview of the project sounded great. He mentioned that this park is in the S-1 Recreational District, and a recent code change only requires site plan amendments to appear before the DRC if it substantially changes the function of the property. He stated that when staff reviews the building permit plans for these improvements a determination will be made as whether DRC is required, however he would not anticipate this to be an issue. Mr. Jones responded that there will be no change in function of the park, it will be mostly interior walkways and landscaping. Mr. Jones stated that they will obtain the proper permits through the appropriate departments.

Mr. Pinney stated that based on comments from the board they are recommending approval of this project.
