A RESOLUTION OF THE CITY OF MARGATE, FLORIDA, APPROVING WITH CONDITIONS A TEMPORARY USE PERMIT FOR A BRAZILIAN FESTIVAL TO BE HELD AT ST. VINCENT CATHOLIC CHURCH, LOCATED AT 6350 NW 18<sup>TH</sup> STREET, FROM JUNE 9 THROUGH JUNE 10, 2018; PROVIDING FOR EFFECTIVE DATE.

WHEREAS, On April 18, 2018, the St. Vincent Catholic Church submitted a Temporary Use Permit (TUP) application for permission to hold a Brazilian Festival at 6350 NW 18<sup>th</sup> Street; and

WHEREAS, The St. Vincent Catholic Church has requested that the festival be permitted to operate until 11 P.M. on Saturday June 9, 2018; and

WHEREAS, The applicant noted an anticipated attendance of 3,500 people for the Brazilian festival; and

WHEREAS, Section 3.24 of the Margate Zoning Code provides that only the City Commission has the authority to approve a TUP application for an outdoor promotional event for a community facility with an anticipated attendance of 500 or more people, and only the City Commission has the authority to approve a TUP application for an event that operates beyond 10 P.M..

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

**SECTION 1:** The foregoing "WHEREAS" clauses are incorporated in and made a part of this Resolution.

**SECTION 2:** That the City Commission of the City of Margate, Florida, hereby approves with conditions a Temporary Use Permit (TUP) application granting permission to the St. Vincent Catholic Church to hold a Brazilian festival at 6350 NW 18<sup>th</sup> Street from June 09-10, 2018, from 4 P.M. to 11 P.M. on Saturday and 9 A.M. to 9 P.M. on Sunday with event set-up to take place June 06-08, 2018, and event breakdown to take place June 11-13, 2018; subject to the following conditions:

- 1) Obtain a Building Permit from the Margate Building Department for the festival, including any temporary lighting.
- 2) That the renovated or new addition of the church building

cannot be used until a certificate of occupancy is issued.

3) That the festival shall be permitted to operate, including breakdown, until June 13, 2018.

**SECTION 3:** That all representations by the applicant are incorporated as part of the conditions for this Temporary Use Permit (TUP).

**SECTION 4:** That this resolution shall become effective immediately upon its passage.
