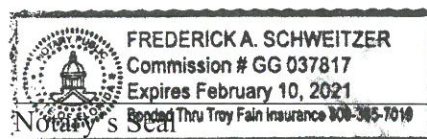

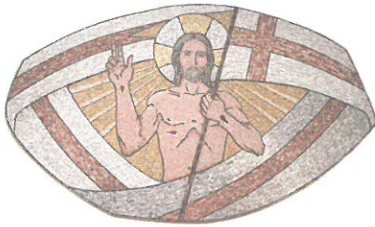

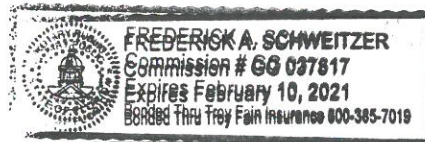
The festival started in 1997 and has been the Brazilian Communities annual and major fund raiser since that date.

The Festival is totally run by St. Vincent Parish and all proceeds will be going to our church.

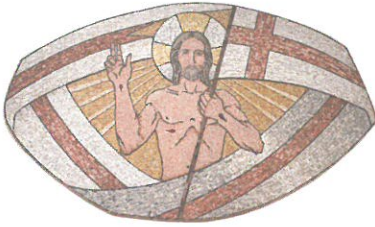

Dear Neighbor:

I am writing on behalf of the parishioners of St. Vincent Catholic Church and would like to invite you and your family to attend the "Annual Brazilian Festival (Festa Junina)" which will be held at our church on June 13th from 4 pm to 12 am and June 14th from 2 pm to 9 pm.

The Festival celebrates rural life and features typical clothing, food, dance (particularly "quadrilha", which is similar to square dancing). The "quadrilha" features couple formations around a mock wedding whose bride and groom are the central attraction of the dancing. The celebrations usually take place in an "arrayal", a huge tent made of raw material that was reserved for special parties in old rural areas. Men dress up as farm boys with large straw hats and women wear pigtails, freckles, painted gap teeth and red-checkered dresses, all in a loving tribute to the origins of Brazilian country music, and of themselves.

The festivities are extremely popular in all urban areas and among all social classes. The festivities also involve dancing, music, typical Brazilian food, drinking, costume wearing and folk dancing. The Festival also coincides with the corn harvest and special dishes are prepared with corn, such as "canjica", "pamonha" and "Brazilian couscous". Dishes may also include peanuts, potatoes, sausages and rice.

The celebrations are very colorful and festive. We look forward to seeing you celebrate with us.
