RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY. **FLORIDA** RELATING TO THE BROWARD COUNTY RULES AND APPEALS; AMENDING SECTIONS 43.1 AND 43.2 OF THE BROWARD COUNTY ADMINISTRATIVE CODE ("ADMINISTRATIVE CODE"), REDUCING THE FEE TO BE COLLECTED IN CONNECTION WITH BUILDING PERMITS AND FOR FILING APPEALS WITH THE BOARD OF RULES AND APPEALS AND UPDATING TITLE OF FLORIDA BUILDING CODE; AND PROVIDING FOR SEVERABILITY, INCLUSION IN THE ADMINISTRATIVE CODE, AND AN EFFECTIVE DATE.

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA:

Section 1. Section 43.1 of the Broward County Administrative Code is hereby amended to read as follows:

43.1. Fee in Connection with Permits.

In compliance with Article IX, Section 9.02D, Broward County Charter, as amended, each governmental authority within Broward County which that is required to issue permits pursuant to the Florida Building Code, Broward County Edition, shall charge a fee in connection with permits issued pursuant to that Code according to the following formula:

a. A fee equal to the greater of \$2.00 or \$0.68 \$0.65 for each \$1,000.00, or any fraction thereof, of "Total Construction Cost" shall be collected for any building, electrical, plumbing, mechanical, engineering, and liquefied petroleum permit issued, including, but not limited to, permits issued for alteration, repair, installation, and demolition.
