The Margate Gourmet Food Truck Events will take place on the following dates as part of the City of Margate Sounds at Sundown Concert Series: Saturdays, October 6, November 3, December 1, 2018; January 5, February 2, March 2, April 6, May 4, June 1, July 6, August 3, and September 7 from 6:00pm-9:00pm at 5701 Margate Blvd., Margate, FL 33063.

Margate CRA Responsibilities:

- Musical entertainment will be provided by the Margate CRA.
- Lighting will be provided by the Margate CRA.
- Portable toilets and handwash facilities will be provided by the Margate CRA.
- The Margate CRA will promote the Food Truck event as part of the Sounds at Sundown Concert Series on the Margate CRA and City of Margate website, through print ads to be run in the Sun-Sentinel and the Margate Forum.
- Event generated trash removal shall be taken care of by Margate CRA. Food trucks are responsible for disposing of their trash, cooking oils and/or any used containers pertaining to food truck operations.

What's Cooking Inc. Responsibilities:

- What's Cooking Inc. will arrange for up to 10-20 Food Trucks to be in attendance for each event, starting out with 15 trucks and then adjusting based on attendance.
- What's Cooking Inc. will promote the Sounds at Sundown Concert Series and Food Truck event on the Gourmet Truck Expo website, Facebook, Instagram and other social media outlets using its extensive network of social media partners.
- What's Cooking Inc. shall pay the Margate Community Redevelopment Agency \$25 per Food Truck.
- If any sponsors are secured for the events, 80% of all sponsorship revenues will go to the Margate Community Redevelopment Agency, 20% will go to Gourmet Truck Expo. Example: The XYZ Company, in order to gain more exposure purchases a sponsorship of the event for \$500. The CRA would keep \$400; What's Cooking, Inc., would receive \$100. This would apply whether the CRA or GTE sells the sponsorship (Optional-subject to Board's approval).
- Food trucks are responsible for disposing of their trash, cooking oils and/or any used containers pertaining to food truck operations.
- What's Cooking Inc. may bring bar services to the events in which case What's Cooking, Inc. shall be responsible for all permits, fees, licenses and insurance requirements to serve alcoholic beverages (Optional-subject to Board's approval).
- What's Cooking, Inc. would prefer if coolers were not brought into the event area, knowing that such a rule is hard to enforce. This would maximize the trucks' opportunities to make sales (Optional).
