I just noticed that the consultant excluded several necessary pricing components from their award recommendation. Those are \$10,000 allowance, \$600 permits, \$100 indemnification and the hourly rates of \$250/hr. for a mechanic and \$100/hr. for a helper. We need a specific dollar amount to award this contract. Please see my breakdown below and advise if you concur.
