A RESOLUTION OF THE CITY OF MARGATE, FLORIDA, APPROVING ACQUISITION OF FIVE (5) POLICE VEHICLES (FULLY EQUIPPED) UTILIZING AN EXISTING FLORIDA SHERIFF'S ASSOCIATION BID AWARD, AND APPROVING WAIVING OF BIDDING FOR ANCILLARY EQUIPMENT TO MAINTAIN STANDARDIZATION WITH PRIOR ACQUISITIONS, WITH THE ACQUISITION BEING FUNDED FROM THE LAW ENFORCEMENT TRUST FUND (FEDERAL) AT A COST NOT TO EXCEED \$131,000.00; PROVIDING FOR EFFECTIVE DATE.

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

SECTION 1: That the City Commission of the City of Margate, Florida approves acquisition of five (5) police vehicles (fully equipped) utilizing the Florida Sheriff's Association bid award and approving waiving of bidding for ancillary equipment to maintain standardization with prior acquisitions, and utilizing funds from the Federal Law Enforcement Trust Fund.

SECTION 2: That the expenditure is deemed to be in the best interest of the City of Margate.

SECTION 3: The Chief of Police recommends the expenditure in Federal Law Enforcement Trust Funds ("LETFs") for purchase of vehicles and ancillary equipment for the Police Department.

SECTION 4: The Chief of Police certifies that the expenditure in LETFs for the vehicles and ancillary equipment for the Police Department, in that the funds will be used for an appropriate law enforcement purpose.

SECTION 5: The Chief of Police certifies that the expenditure in LETFs for the vehicles and ancillary equipment for the Police Department, in that the funds are not being used as a normal source of revenue for the Police Department.

SECTION 6: The Chief of Police certifies that the

expenditure in LETFs for the vehicles and ancillary equipment for the Police Department in that the funds were not considered in the adoption and approval of the Police Department budget.

SECTION 7: That the Mayor and City Manager are authorized and directed to execute contracts for the above acquisition, and the administration is authorized to issue a purchase order and execute all associated documents in order to implement same.

SECTION 8: That this Resolution shall become effective immediately upon its passage.
