A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA, APPROVING DESIGNS CREATED BY THE FLORIDA DEPARTMENT OF TRANSPORTATION TO CONSTRUCT BIKE/MOBILITY IMPROVEMENTS ALONG NORTHWEST 54TH AVENUE, NORTHWEST 31ST STREET AND NORTHWEST 62ND AVENUE WITHIN CITY RIGHT OF WAY, FROM WEST SAMPLE ROAD TO APPROXIMATELY NORTH BAY DRIVE; AUTHORIZING IMPLEMENTATION OF SAME; AND FURTHER EXPRESSING ITS INTENT TO TAKE OVER MAINTENANCE OF THESE BIKE/MOBILITY IMPROVEMENTS WITHIN THE CITY RIGHT OF WAY; PROVIDING FOR EFFECTIVE DATE.

WHEREAS, the State of Florida Department of Transportation (hereinafter FDOT) is authorized by the Broward Metropolitan Organization to undertake a project identified as Financial Project #437830-1-52-01, within Broward County's geographical limits; and

WHEREAS, pursuant to said project, FDOT agrees to provide bike/mobility improvements (addition of bicycle lanes, sharrows, or multi-use paths) along Northwest 54th Avenue, Northwest 31st Street and Northwest 62nd Avenue, from West Sample Road to approximately North Bay Drive, not including the intersection with North State Road 7; and

WHEREAS, this project is on the Metropolitan Planning Organization (MPO) priority list; and

WHEREAS, since this is an Off State Highway System Project, FDOT will not provide maintenance for the Northwest 54th Avenue, Northwest 31st Street and Northwest 62nd Avenue bike/mobility improvement project segments after construction is completed. A Maintenance Agreement will be required to establish the City as the maintaining agency for the proposed sidewalk segment and a Right of Way Certification; and

WHEREAS, pursuant to such authority, FDOT and the City are desirous of having the FDOT implement mobility improvements in cooperation with the City of Margate more particularly described as Financial Project ID 437830-1-52-01; and

WHEREAS, FDOT and the Board MPO presented conceptual improvements to the City Commission on November 1, 2017; and

WHEREAS, FDOT and city staff hosted a public workshop on February 15, 2017 for resident and stakeholder input; and

WHEREAS, the City Commission authorized and requested FDOT to develop bike/mobility plans for project segments located on Northwest 54th Avenue, Northwest 31st Street and Northwest 62nd Avenue on April 18, 2018 via Resolution 18-044; and

WHEREAS, FDOT has developed plans for bike/mobility improvements and is seeking approval of the Margate City Commission.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

SECTION 1: The foregoing recitals are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2: The above referenced bike/mobility plans that FDOT has developed are separated into Section A and Section B. Section A consists of portions of Northwest 31st Street and Northwest 54th Avenue located east of State Road 7 and running east and north to Sample Road. Section B consists of portions of Northwest 31st Street and Northwest 62nd Avenue located west of State Road 7 and running west and north to the Margate city limits.

- a. The City Commission supports the implementation of [insert plan option: shared lane markings OR on-street bicycle lanes (10'-11'-4.5')] on Section A of the bike/mobility project.
- b. The City Commission supports the implementation of [insert plan option: a multi-use path OR on-street bicycle lanes (10'-11'-6'/10'-11'-4.5')] on Section B of the bike/mobility project.

SECTION 3: It is the intent of the City of Margate to take over the maintenance of any bike/mobility improvements along Northwest 54th Avenue, Northwest 31st Street and Northwest 62nd Avenue, within City right of way from West Sample Road to approximately North Bay Drive, not including the intersection with North State Road 7, that result from this program. The City Commission hereby authorizes the City Manager, or an approved designee selected by the City Manager, to execute a maintenance agreement.

SECTION 4: SEVERABILITY. If any section, sentence, clause or phrase of this Resolution is held to be invalid or unconstitutional by any court of competent jurisdiction, then said holding shall in no way affect the validity of the remaining portions of the Resolution.

SECTION 5: This Resolution shall take effect immediately upon its passage and adoption and providing for distribution to MPO Board, FDOT and Coral Springs.
