ASSISTANT CITY MANAGER, CALE CURTIS said that they could not create a priority for Margate renters to get on the list but they could assist them by getting pre-qualified and going through the process. He said that it was on a first come, first served basis.

GRANTS MANAGER TANYA WARD-BENJAMIN explained that in terms of purchase assistance, the process was on a first come, first served basis. She advised that there was no list for purchase assistance but the County had a Home Repair list. She said that anyone who called about the program was provided with the steps and requirements.

RICHARD ZUCCHINI, 380 LAKEWOOD CIRCLE E, #B referenced repair grants and said that he was trying to assist a resident who needed a new roof which was estimated at \$4,000. He advised that they have to be able expedite this type of process as they could not wait eight or nine years. He also wanted to make sure that they were vetting the recipient to ensure that they were still in the same status and therefore, eligible for the repair grant.

CITY MANAGER MAY confirmed that they were doing all of those things. He said that the resident for the roof repair would not qualify due to the type of housing she lived in.
