ORDINANCE OF THE CITY OF MARGATE, FLORIDA;  
AMENDING ORDINANCE 2015-6 TO APPROVE AN  
AMENDMENT TO FRANCHISE AGREEMENT FOR SOLID  
WASTE AND RECYCLING COLLECTION SERVICES WITH  
WASTE MANAGEMENT, INC. OF FLORIDA, RELATING TO  
THE PROVISIONS OF THE AGREEMENT FOR BULK WASTE  
AND YARD WASTE COLLECTION SERVICES; APPROVING A  
RATE ADJUSTMENT FOR THE AMENDED BULK WASTE AND  
YARD WASTE COLLECTION SERVICES; PROVIDING FOR  
REPEAL; PROVIDING FOR SEVERABILITY; PROVIDING  
FOR INCLUSION IN THE CITY'S CODE OF ORDINANCES  
BY REFERENCE; AND, PROVIDING FOR AN EFFECTIVE  
DATE.

WHEREAS, on November 4, 2015, the City Commission  
adopted Ordinance 2015-6, which approved an exclusive  
Franchise Agreement for Solid Waste and Recycling Collection  
Services with Waste Management, Inc., of Florida; and,

WHEREAS, the parties desire to enter into an Amendment  
to Franchise Agreement for Solid Waste and Recycling  
Collection Services to amend the provisions relating to the  
collection of yard waste and bulk waste.

WHEREAS, the City Commission desires to utilize the  
Citizen Project Initiative fund to provide for funding the  
first fiscal year ending September 30, 2019, of these  
additional services and to thereafter, revise the rate  
schedule for the services accordingly.

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF  
MARGATE, FLORIDA:

SECTION 1: The aforementioned "WHEREAS" clauses are  
hereby ratified by the City Commission and incorporated  
herein.

SECTION 2: That the City Commission of the City of  
Margate hereby approves the Amendment to the Franchise  
Agreement for Solid Waste and Recycling Collection Services  
with Waste Management, Inc. of Florida, a copy of which is  
attached hereto as Exhibit "A", and authorizes the execution

thereof, and approves the revised rate schedule attached hereto as Exhibit "B".

Section 3: All ordinances or parts of ordinances in conflict herewith are and the same is hereby repealed to the extent of such conflict.

Section 4: If any section, sentence, clause, or phrase of this ordinance is held to be invalid or unconstitutional by a court of competent jurisdiction, then said holding shall in no way affect the validity of the remaining portions of this ordinance.

Section 5: It is the intention of the City Commission that the provisions of this ordinance shall become and be made a part of the City of Margate Code by reference.

Section 6: This ordinance shall become effective immediately upon adoption at its second reading.
