RFP DUE DATE AND TIME HAS BEEN EXTENDED TO 11:00 A.M., TUESDAY, JANUARY 8, 2019.

QUESTIONS AND CLARIFICATIONS:

1. Do the LED fixtures need to be in the shade?

ANSWER: It depends on the proposed shade frame design. The fixtures shall be located to provide even light coverage in the designated play areas.

2. Do you have an estimate or budget for this project?

ANSWER: Estimated budget for this project is \$800,000.00.

3. Do the 6 benches need to have separate shading or do they need to be within the playground area?

ANSWER: All benches to be located inside the drip line of the overhead structure.

4. Can there be multiple canopies for the shade or one large shade covering?

ANSWER: Either will be acceptable, design of the shade shall be at the discretion of the installer.

5. Does the new shelter need to be in wood or steel?

ANSWER: Steel powder coat finish, with tile roof matching existing building.

6. Is the walking trail part of the improvements?

ANSWER: No

7. What surface do you require for the playground?

ANSWER: Either poured in place rubber or artificial turf.

8. What surface do you require for the fitness area?

ANSWER: Engineered wood fiber.

9. Does the playground have a pre-determined theme by the City?

ANSWER: No

10. Can you provide a survey in PDF or CAD?

ANSWER: Yes, please see Exhibit C.

11. When do the park improvements need to be completed?

ANSWER: September 30, 2019

12. What should be the overall size of the playground?

ANSWER: Minimum 5,000 SF/Maximum 8,000 SF

13. Would any structural issues found on the pre-existing shelters need to be corrected?

ANSWER: No

14. Will the RFP due date be extended?

ANSWER: Yes, the due date has been extended to Tuesday, January 8, 2019 at 11:00 A.M.

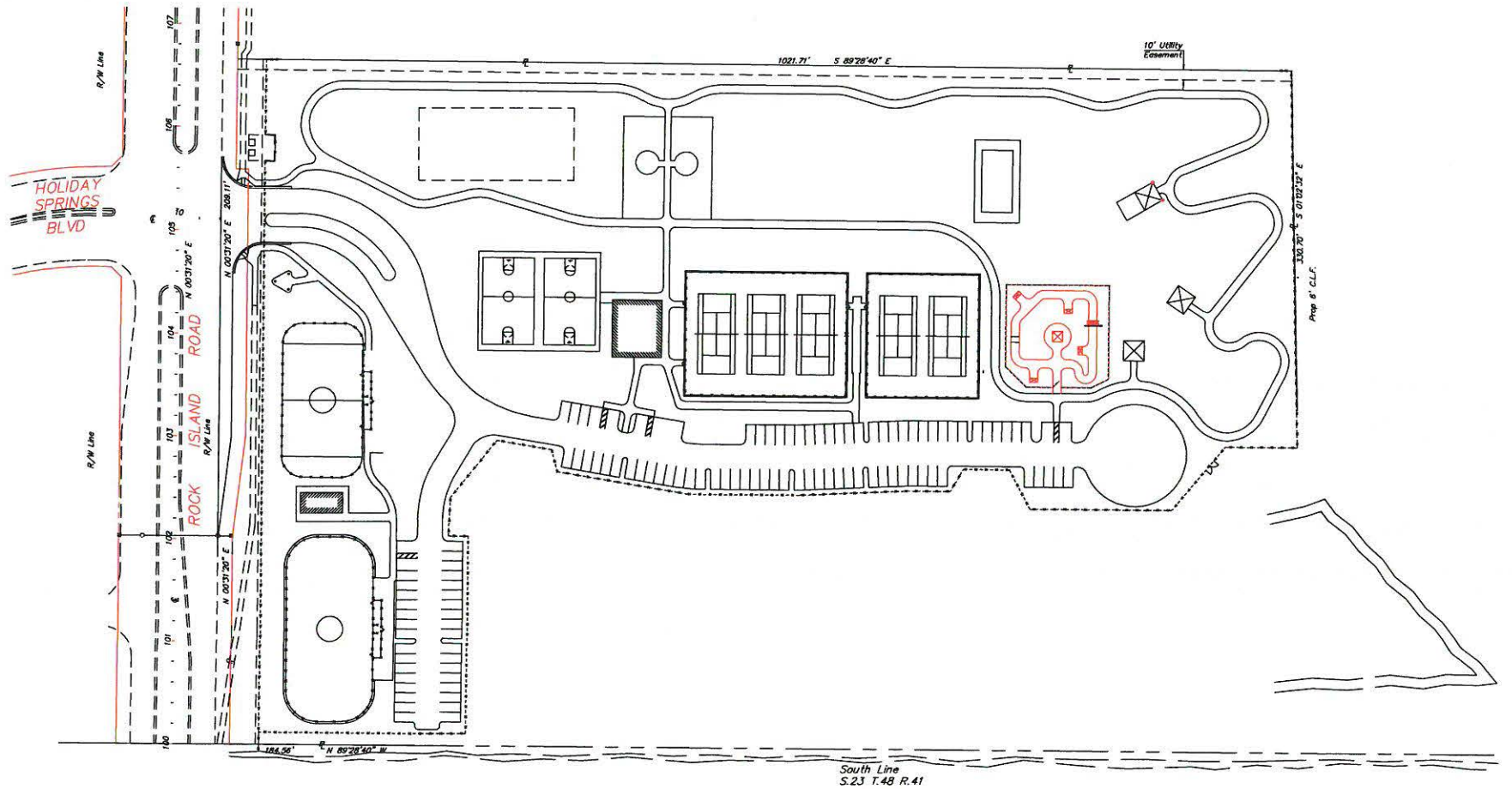
