Request to Waive Bidding Requirements Due to Sole Source for the

Purchase of Zenner Meters from Fortiline Waterworks, Inc.

The Department of Engineering and Environmental Services (DEES) is responsible for the installation and maintenance of all water meters within the City. Residential water meters are not only used to monitor water usage for billing but are also used for leak detection. Zenner is the manufacturer of the water meters that are utilized by DEES for all residential customers. This standardization of Zenner meters is to coincide the City's conversion of our existing water meter reading infrastructure per resolution 16-165 which also uses Zenner meters.

Fortiline Waterworks, Inc is the sole source vender for Zenner water meters and meter parts. As Fortiline Waterworks, Inc. has not yet been declared a sole source by the City Commission, I am requesting that we waive bidding requirements for this purchase 400 meters for a total amount of \$23,576.00. It is my understanding that when the sole source list is updated within the next few months that Fortiline Waterworks, Inc will be added, however we do not have enough meters in stock to sustain the City until that point.
