BID 2019-003 Lift Station No. 7 Renovation - Bid Rejection

Recommendation

The City received ten (10) bids for the Lift Station No. 7 Renovation project (Bid No. 2019-003) on February 21, 2019 ranging from \$449,990 to \$1,433,000.

While in the bidding process, it was discovered that the construction of the new wet well for the lift station would not be possible without directly violating OSHA regulations. The existing FPL power line, that runs parallel to the existing lift station, is approximately 30LF high and encroaches the required work zone area of the crane that is needed to perform the construction activities. According to OSHA 29 CFR 1926 Subpart CC regulation, no crane work zone area may encroach within 20LF of the energized power line; this encroachment area was increased by OSHA from the prior 10LF requirement (up to 50Kv).

The only other option allowable by OSHA regulations would be to de-energize and ground the existing power line during construction activities. After discussing this option with FPL, it was determined to not be a feasible option as the power line feeds a large majority of business along 441 and there is no redundant system in place.

In an attempt to push the project forward, a re-design was performed to change the configuration of the lift station to meet OSHA requirements. The updated design was released in addendum No. 3 along with additional clarification information. After the release of the addendum, it came to my attention that during the initial design process proper utility research, locates and soft digs were not performed by direction of the City. The existing utility information that was submitted as part of the final plans were estimated/approximated. Not having accurate information drastically raises the chance of unforeseen conflicts arising during the construction of the project and could result in changer orders and/or design changes which would be at the expense of the City.

Rather than opening the City up to potential safety issues and time consuming/costly change orders and design expenses, I recommend that the City reject all bid submissions and rebid the project after all pending utility issues have been addressed. Pending the approval to reject all bid submissions, the City is going to coordinate with FPL to have the existing power line buried to eliminate this hazard for both construction operations and for City staff who

perform maintenance and repairs on the lift station. Once FPL has buried the existing line and proper utility investigations have taken place the City will re-bid the renovation project.

4. How far are the existing power lines from the lift station? If they are closer than 20LF will they be de-energized?

Answer: See revised plans. The reconfiguration of the station will allow the contractor to operate within OSHA guidelines.
