A RESOLUTION OF THE CITY OF MARGATE, FLORIDA, APPROVING ACQUISITION OF A 2019 RESCUE UNIT FOR THE FIRE DEPARTMENT FROM REV RTC D/B/A HALL-MARK RTC, TO INCLUDE A 2019 FREIGHTLINER M2 CHASSIS WITH PRICING PER THE FLORIDA SHERIFF'S ASSOCIATION BID NO. FSA18-VEF13.0; PROVIDING FOR WAIVING OF BIDDING FOR A CUSTOM WHEELED COACH AMBULANCE BUILD-OUT AS STANDARDIZATION TO MATCH EXISTING UNITS; COST NOT TO EXCEED \$336,591.46; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on May 4, 2018, the Florida Sheriff's Association Contract No. FSA18-VEF13.0 ("Fire Rescue Vehicles and Other Equipment") went into effect; and

WHEREAS, on February 20, 2019 REV RTC D/B/A HALL-MARK RTC proposed to furnish to the City of Margate Fire Rescue Department, with pricing pursuant to the Florida Sheriff's Association Bid. No. FSA18-VEF13.0, one (1) 2019 Custom Wheeled Coach Type 9, Rescue Vehicle on a 2020 Freightliner M2 Extended Cab and Chassis, to be custom built in accordance with the requirements of the City of Margate Fire Rescue Department; and

WHEREAS, Section 166.021(1), Florida Statutes, provides that municipalities "may exercise any power for municipal purposes except as otherwise provided by law"; and,

WHEREAS, the City Commission of the City of Margate, Florida deems it to be in the best interest of the citizens and residents of the City of Margate to enter into an Agreement with REV RTC D/B/A HALL-MARK RTC (hereinafter, "Contractor").
