

1. CONCRETE FOOTINGS SHALL BE DESIGNED TO REACH A COMPRESSIVE STRENGTH OF 3,000PSI IN 28 DAYS WITH A MAX WATER-CEMENT RATIO OF 0.4. ALL MIXING, TRANSPORTING, PLACING, & CURING OF CONCRETE SHALL BE IN ACCORDANCE WITH ACI 318.
2. SURROUNDING SOIL SHALL BE COMPACTED TO 95% OF OPTIMUM DENSITY BASED ON ASTM D 698, AND SHALL HAVE A BEARING CAPACITY OF 2000 PSF MIN AND SHALL BE VERIFIED BY OTHERS PRIOR TO CONSTRUCTION. AND SHALL HAVE A MINIMUM CLASSIFICATION OF SW, SP, SM, SC, GM, OR GC.
3. STEEL REINFORCEMENT: ALL REINFORCEMENT SHALL BE AS DETAILED, FREE FROM OIL, LOOSE SCALE AND RUST. REINFORCEMENT SHALL BE LAPPED, PLACED, SUPPORTED AND FASTENED ACCORDING TO THE "ACI DETAILING MANUAL" AND ACI 318. ALL STEEL SHALL BE SECURELY HELD IN PLACE DURING POURING OF CONCRETE. 
