A RESOLUTION OF THE CITY OF MARGATE, FLORIDA, APPROVING A FIRST AMENDMENT TO THE INTERLOCAL AGREEMENT BETWEEN BROWARD COUNTY AND CITY OF MARGATE FOR OPTIONAL COUNTY SERVICES FOR KEEP BROWARD BEAUTIFUL, HOUSEHOLD HAZARDOUS WASTE, AND BULK TRASH AND YARD WASTE DROP-OFF PROGRAMS; PROVIDING FOR EXTENSION OF TERM; PROVIDING FOR EFFECTIVE DATE.

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

SECTION 1: That the City Commission of the City of Margate, Florida approves the First Amendment to the Interlocal Agreement between Broward County and City of Margate For Optional County Services For Keep Broward Beautiful, Household Hazardous Waste, and Bulk Trash and Yard Waste Drop-Off Programs for a term ending September 30, 2019.

SECTION 2: That the Mayor and City Manager are authorized and directed to execute this Amendment on behalf of the City of Margate, a copy of which is attached and made a part of this Resolution.

SECTION 3: That this Resolution shall become effective immediately upon its passage.

This is a First Amendment to the Interlocal Agreement for Optional County Services for Keep Broward Beautiful, Household Hazardous Waste, and Bulk Trash and Yard Waste Drop-Off Programs ("Agreement") between Broward County, a political subdivision of the State of Florida ("County") and City of Margate, a municipality established under the laws of the State of Florida ("City") (collectively, the "Parties").

Recitals 8 1

- A. On August 28, 2012, the Board of County Commissioners approved the form of an interlocal agreement to allow municipalities in Broward County to use County services for Keep Broward Beautiful, Household Hazardous Waste, and Bulk Trash and Yard Waste programs (the "Programs") on a fee-for-service basis.
- B. Keep Broward Beautiful program focuses on the organization, education, and coordination of volunteers for the removal of litter, including Adopt-A-Street, waterway cleanups, beach sweeps, and municipal events.
- C. Household Hazardous Waste program involves three permanent locations for residential drop-off of household hazardous waste and electronics.
- D. Bulk Trash and Yard Waste Drop-Off program involves three permanent locations for bulk trash and residential yard waste drop-off.
- E. On December 12, 2012, City entered into the Agreement with County. The Agreement currently expires on September 30, 2018.
- F. County is in the process of evaluating the next steps for the Programs.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, County and City hereby agree as follows:

- 1. The Agreement, which expires on September 30, 2018, is extended for one year, with a new expiration date of September 30, 2019.
- 2. All other terms, conditions, and covenants contained in the Agreement shall remain in force and effect.

IN WITNESS WHEREOF, the Parties hereto have made and executed this First Amendment to the Interlocal Agreement: BROWARD COUNTY, through its County Administrator, authorized to execute same pursuant to Board action at the <u>April 10</u>, <u>2018</u> meeting, and the <u>City of Margate</u>, signing by and through its <u>Mayor</u> and <u>City Manager</u>, duly authorized to execute same.
