ORDINANCE OF THE CITY OF MARGATE, FLORIDA; AMENDING ORDINANCE 2018-10 PROVIDING FOR THE ADDITIONAL COST OF THE WEEKLY BULK WASTE COLLECTION TO BE PLACED ON RESIDENTS' UTILITY BILLS; PROVIDING FOR REPEAL; PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN THE CITY'S CODE OF ORDINANCES BY REFERENCE; AND, PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on November 4, 2015, the City Commission adopted Ordinance 2015-6, which approved an exclusive Franchise Agreement for Solid Waste and Recycling Collection Services with Waste Management, Inc., of Florida; and,

WHEREAS, on December 12, 2018, the City Commission adopted Ordinance 2018-10, providing for the first Amendment to Franchise Agreement for Solid Waste and Recycling Collection Services and utilized the Citizen Project Initiative fund to provide for funding the first fiscal year ending September 30, 2019.

WHEREAS, the City Commission desires to continue the weekly bulk waste collection services which shall be funded as a pass-thru cost placed on the residents' utility bills.

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

 $\underline{\text{SECTION}\ 1}\colon$ The aforementioned "WHEREAS" clauses are hereby ratified by the City Commission and incorporated herein.

SECTION 2: That the City Commission of the City of Margate hereby approves the funding of the Franchise Agreement for Solid Waste and Recycling Collection Services with Waste Management, Inc. of Florida, to be a pass-thru cost placed on the residents' utility bill.

 $\underline{\text{Section 3}}$: All ordinances or parts of ordinances in conflict herewith are and the same is hereby repealed to the extent of such conflict.
