2) PUBLIC DISCUSSION

MS. JONES congratulated the newly appointed Mayor Ruzzano and Vice Mayor Schwartz.

JULI VAN DER MEULEN, 2913 NW 68 LN. thanked Officer Anthony DeMarize for his professionalism in dealing with a 911 incident.

Discussion ensued.

MS. KROMBHOLZ discussed a recent Commission meeting and referenced Commissioner Arserio. She asked why the residents were still paying \$300 for the Fire Station when nothing had been built. She also complained about the City Commission's pay raise and \$300 car allowance.

COMMISSIONER ARSERIO responded to Ms. Krombholz's comments.

Discussion ensued.

MARGATE HEALTH AND REHABILITATION CENTER LORDACHA ST. VIL had a proposal for her residents and asked to set up some donation boxes.

Discussion ensued to support the Margate Health & Rehab Center to setup donation boxes in City Hall to collect gifts for senior citizens during the holidays.

CITY MANAGER CALE CURTIS requested that Ms. St. Vil leave her contact details with the City Clerk.

CHARLIE ARTNER, 6631 NW 22ND COURT discussed the difficulties of a Trailer parking on the corner of his street.

CITY MANAGER CALE CURTIS explained that this matter would be addressed with the Code Department.

Discussion ensued on Code Compliance.

MS. DECRISTOFARO advised that one of their Community Emergency Response Team (CERT) members passed away and thanked Fire Chief Lorenzo and staff for their support and flowers.

MR. ALIANIELLO thanked current Mayor Caggiano for his kindness and congratulated newly elect Mayor Ruzzano. He also thanked newly elect Vice Chair Schwartz and spoke about Commissioner Simone being overlooked.

RICHARD ZUCCHINI, 380 LAKEWOOD CIRCLE E explained that he applauded the City's efforts to support patriotism and veteran issues. He also discussed the submittal of an application for a Veteran's care facility.

Discussion ensued.

CITY ATTORNEY JANETTE M. SMITH advised the Commission that the facility was in the middle of litigation and cautioned them on the litigation and appeal process.

Discussion ensued.

MS. SANCHEZ congratulated Mayor Ruzzano and Vice Mayor Schwartz and also highlighted that Commissioner Simone was being overlooked. She thanked the Police Department and Officers Samuel Phanor and Rachel Druzbik for a fantastic presentation and seminar which they gave at a Clubhouse in Paradise Gardens III. She also requested an update on the boil water notice.

CITY MANAGER SMITH said that he would provide an update under City Manager's Comments.

3) COMMISSION COMMENTS

COMMISSIONER SIMONE explained that the Police Department did a great job which resulted in catching three burglary suspects. She advised to recycle responsibly and discussed her recent attendance at the Solid Waste and Recycling Selection meeting pertaining to the nine member working group. She informed that a resident emailed her with an idea of implementing a Margate Military Banner program. Commissioner Simone asked for CONSENSUS from the City Commission to have a Discussion & Possible Action Agenda Item added to the December 4th, 2019 Regular City Commission meeting to discuss a Margate Military Banner Program.

CONSENSUS was given by the City Commission.

COMMISSIONER SIMONE congratulated newly elected Broward County's Mayor Dale V. C. Holness, Broward County School Board Chair Donna P. Horn and Vice Chair Dr. Rosalind Osgood. She referenced The Metropolitan Planning Organization (MPO) Action Agenda and advised that they did not have any funded projects for 2045 The Metropolitan Transportation Plan or the Complete Streets & Localized Initiatives program (CSLIP) plan. She congratulated newly elected Mayor Ruzzano, Vice Mayor Schwartz and thanked the residents who spoke on her behalf.

COMMISSIONER ARSERIO congratulated incoming Mayor Ruzzano and Vice Mayor Schwartz. He said that he would like to see the residents vote for a ceremonial Mayor. He congratulated the Fire and Police Departments and referenced an incident in his neighborhood. He said that he was not aware of the Food Eating contest and the CERT memorial.

COMMISSIONER SCHWARTZ thanked both the outgoing and incoming Mayor and for the City Commission for voting for her as Vice Mayor. She highlighted and congratulated Firefighter Santana's retirement. She suggested that employees that were retiring should also be recognized at the City Commission meetings. She discussed a State Holder's Forum at Atlantic West Elementary School request for staff and resident's input for a new Principal. She highlighted a problem with a School Resource Officers' (SRO) radio at an elementary school. She also highlighted the City's forthcoming Winter Fest in December. She requested the City Manager contact the City's lobbyist as the legislative session started in January 2020 and referenced items that they were unable to obtain. She spoke about issues pertaining to Bulk pick-up and recommended that the time allowed should be changed from three days to one.

Discussion ensued on the time allowed for Bulk pick-up and a civil citation.

VICE MAYOR RUZZANO congratulated Mayor Caggiano for doing a great job. He thanked everyone for supporting him. He discussed the garbage and Bulk pick-up and referenced the sign Code.

Discussion ensued on garbage and Bulk pick-up.

VICE MAYOR RUZZANO congratulated Development Services' Business Development Coordinator Robinson for the Small Business Saturday in Margate and also referenced the Keep Our Money In Margate Group (KOMIM). He indicated that they were looking into re-zoning the Golf Course back to a golf course. He advised that the City of Coconut Creek were looking at alternative ways on how they could do their Fire Department. He referenced the lake behind Wal-Mart and questioned Public Works why it was a different color. He discussed representation for the Solid Waste and Recycling and referenced the nine Board member voting process and a lawsuit.

Discussion ensued about the nine board members of the recycling program.

MAYOR CAGGIANO advised that there would be a core group sitting on the Board and as this would involve a lot of work, Margate did not have the staff to do it. He explained that either Commissioner Simone or himself would attend future meetings to ensure that their City was represented.

Discussion ensued on meetings being noticed for the Sunshine.

COMMISSIONER ARSERIO discussed the City's Fire Department's relationship with Coconut Creek and said that the City should start planning if they proposed to leave.

CITY MANAGER CURTIS referenced the solid waste system and confirmed that there would not be a voting representative on the Board but they had assigned a staff member to the Technical Advisory Committee.

Discussion ensued on representation for the recycling program, bulk pick-up and the lawsuit with New Urban vs. The City of Margate.

VICE MAYOR RUZZANO discussed cars in Coral Bay that were stacked on properties.

Discussion ensued on abandoned vehicles.

CITY ATTORNEY SMITH asked for CONSENSUS from the City Commission to modify the Code regarding Abandoned Vehicles.

Discussion ensued.

CONSENSUS was given by the City Commission to have the City Attorney bring back an Ordinance to modify the Code regarding Abandoned Vehicles to eliminate the provision stating as required by law.

VICE MAYOR RUZZANO discussed whether artificial turf counted as landscaping under the City's Code.

Discussion ensued.

CITY MANAGER CURTIS asked if there was CONSENSUS by the City Commission to amend the Code pertaining to artificial turf.

Discussion ensued.

Vice Mayor Ruzzano asked for CONSENSUS to modify the Code to allow artificial turf as a permitted landscaping option. CONSENSUS was given by the City Commission.

MAYOR CAGGIANO discussed Firefighter Santana's 30-year retirement party. He advised everyone to attend the City's Winter Festival and thanked them for his time serving as the Mayor. He also congratulated newly elect Mayor Ruzzano.

CONSENSUS was given by the City Commission to move up Item 6A before Commission Comments.

DEPARTMENT OF ENVIRONMENTAL AND ENGINEERING SERVICES (DEES) INTERIM DIRECTOR CURT KEYSER introduced the DEES Project Manager, Attorney for Palm Beach Aggregates for Ernie Cox and Broward County's Susan Bodman.

PALM BEACH AGGREGATES AND PROJECT MANAGER ERNIE COX provided a PowerPoint presentation on this Item. He explained that for the last 13 years, there had been a collaborative process with South Florida Utilities, South Florida Water Management District (SFWMD), Florida Department of Transport (FDOT) and Florida Department of Environmental Protection and that they have all worked together to create a regional water resources project. He advised that Broward, Sunrise, Dania and Hallandale Beach have signed up to 13,000,000 gallons per day. He indicated that he was asking the City for 2,000,000 gallons that Pompano Beach were moving forward with 2,000,000 gallons and Fort Lauderdale with 6,000,000 gallons.

DEES INTERIM DIRECTOR KEYSER spoke again on this Item and explained that they were going to be facing a restriction on the amount of water available and that there was no question that they needed an alternative water supply for the City. He indicated that they anticipate a \$9,200,000 capital outlay for this Item.

Discussion ensued together with a question and answer session.

MR. ZUCCHINI asked a number of questions on this Item.

Discussion ensued.

MR. ALIANIELLO spoke in support of this Item.

Discussion ensued.

MRS. VAN DER MEULEN spoke on this Item.

Discussion ensued.

A motion was made by Commissioner Arserio, seconded by Vice Mayor Ruzzano, to table this item to the next Regular City Commission meeting on December 4th, 2019.

City Manager's Report heard immediately after Item 6A.

CITY MANAGER CURTIS provided an update on the precautionary boil water alert that the City issued.

Discussion ensued on the time the precautionary boil water notice would end.

CITY MANAGER CURTIS discussed the Shop with a Hero initiative at Wal-Mart and the Police Department's toy drive. He gave kudos to the Finance Department which was awarded the Government Finance Officers Association Certificate of Achievement for Excellence in Financial reporting for fiscal year 2018.

CITY ATTORNEY SMITH said that it was five months since she had been working with the City. She said that there had been many questions on Code re-writes at this

meeting. She indicated that she had received over 200 matters and that she had closed out approximately seventy of them. She requested a prioritized list and said that it was a very progressive Commission. She also advised that they were able to close out a lot of different lawsuits and indicated that the lawsuit by Mr. Arthur J. Krell had been dismissed for a lack of prosecution. She announced that she had a new Executive Secretary/Paralegal.

CITY CLERK JOSEPH J. KAVANAGH congratulated incoming Vice Mayor Schwartz and Mayor Ruzzano and outgoing Mayor Caggiano.
