AN ORDINANCE AMENDING THE CODE OF THE CITY OF MARGATE, FLORIDA, APPENDIX A ZONING, ARTICLE PROVISIONS, III - GENERAL SECTION 3.10 ABANDONED VEHICLES; PROVIDING FOR DEFINITIONS; PROVIDING REPEAL; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF

MARGATE, FLORIDA:

SECTION 1: That the Code of Ordinances of the City of Margate, Florida, Appendix A Zoning, Article III. - General Provisions, Section 3.10 - Abandoned vehicles, shall be amended to read as follows:

Section 3.10. - Abandoned vehicles.

inoperative vehicles; (A) Abandoned or storage vehicles; unlawful. It is hereby declared unlawful and a nuisance to the general public to leave any abandoned or inoperative vehicle, as defined in Section 2.2 or 40.16 of the Zoning Code of the City of Margate, or vehicle without valid registration, if one is required by law, or any parts thereof, in the public streets, alleys, rights-of-way or upon any private property. It is hereby prohibited for any owner or person in control of any vehicle or part thereof to leave same abandoned or inoperative upon the public streets, alleys, or rightsof-way or upon any other public or private property within the City of Margate, or for the owner or person in control of any such vehicle or the owner, occupant, lessee, person in control, or person possession of any property to permit or suffer the same to be stored on any privately owned property, unless said vehicle is stored inside a completely enclosed structure or a designated storage area. Any such designated storage area shall be in a B-3, TOC-C, or M-1 district, and

enclosed by a seven-foot concrete block wall stuccoed on any side visible from areas outside of the property where it is situated. No storage area or wall surrounding same shall be located in a required setback area.

- The above prohibition shall not apply to motor vehicles (1)which are offered for sale in a lot or space specifically designated and zoned for the sale of new or used vehicles where adequate space has been provided for same and a Local Business Tax Receipt has been issued by the City of Margate.
- The above prohibition shall not apply to motor vehicles which are parked on private property zoned for vehicle repair while said vehicles are temporarily and actively being repaired by a business or concern which has been issued a Local Business Tax Receipt by the City of Margate.

[Note to Municode: The remainder of this section shall remain as codified.1

- SECTION 4: All ordinances or parts of ordinances in conflict herewith are and the same is hereby repealed to the extent of such conflict.
- If any section, sentence, clause, or SECTION 5: of this ordinance is held to be invalid unconstitutional by a court of competent jurisdiction, then said holding shall in no way affect the validity of the remaining portions of this ordinance.
- SECTION 6: Ιt is the intention of the City Commission that the provisions of this ordinance shall become and be made a part of the City of Margate Code, and that the sections of this ordinance may be renumbered or relettered and the word "ordinance" may be changed to "section", "article" or such other appropriate word or phrase in order to accomplish such intentions.
- This ordinance shall become effective SECTION 7: immediately upon adoption at its second reading.
