Current Margate Code

- Package Sales:
 - Limited to 7a.m. to 12 midnight, every day.
- Consumption on the premises:
 - Limited to 8a.m. to midnight, Monday through Saturday
 - Limited to 12 noon to 12 midnight, Sunday

Current Margate Code (continued)

- Special Permits
 - Extended hours (late night)
 - Sunday morning brunch
 - Only for consumption on premises licenses
 - Applications filed through City Clerk's office, require City Commission approval, and annual renewal
 - Establishment must close or be able to lock up premises where alcoholic beverages are kept, stored or dispensed after closing hours
 - "Segregated by partition and locked doors"

Current Margate Code (continued)

- Special permits for extended hours
 - ▶ 8a.m. until 2a.m. the following day, Monday through Thursday
 - ▶ 8a.m. Friday until 4a.m. the following Saturday
 - ▶ 8a.m. Saturday until 4a.m. the following Sunday
 - 12 noon until 2a.m. the following Monday
 - New Year's Eve 8a.m. until 4a.m. on New Year's Day
 - St. Patrick's Day 8:00a.m. until 4:00am on March 18

Current Margate Code (continued)

- Sunday morning hours permit
 - Only for 2COP or 4COP licenses
 - Sunday hours start at 10a.m., as an accompaniment to a full-course meal

Proposed Changes

- No changes to package sales
- Consumption on the premises
 - Hours limited to 8:00a.m. until 2a.m. the following day, Monday through Saturday, and 11:00a.m. to 2a.m. on Sunday
 - No special permits
 - Establishment must close or be able to lock up premises where alcoholic beverages are kept, stored or dispensed after closing hours
 - "Segregated by partition and locked doors"

Proposed Changes (continued)

- Consumption on the premises
 - Allow sales and service until 4a.m. on the following dates:
 - January 2nd, March 18th, May 6th, July 5th, December 25th, and December 26th.
- ► Effective date of Ordinance = October 1, 2020

PZB Recommendation

- Allow alcohol service until 4a.m. on the following dates:
 - January 2nd, March 18th, May 6th, July 5th, December 25th, and December 26th.
- Allow businesses to request extended hours through the TUP process
