Good morning Peany,

I trust that you have received our complete application and that it is now going through your review process. I have a separate question related to the permitting of this project which I hope you can assist us with.

Sec 31-2 of the Margate City Code (attached) requires that when constructing a new building, any adjacent, overhead utility lines must be placed underground. As highlighted on page 3 of the attached, this requirement does not apply to electrical transmission lines with a rated load in excess of 27.000 volts.

I'm certain that this code section is not intended to apply to the major FPL transmission lines adjacent to the proposed Fire Station. I also have to believe that in the aggregate, those lines have a maximum capacity well in excess of 27kV, however, City staff is requesting confirmation of that from FPL.

Can you, or someone with FPL please confirm that the total aggregate capacity of all these adjacent power lines exceeds 27kV? We don't need to know the actual capacity, just that it exceeds 27kV. Please let me know if you need additional information or if there is someone else to whom I should direct this question.
