AN ORDINANCE OF THE CITY OF MARGATE, FLORIDA, AMENDING APPENDIX-A ARTICLE IIIVXX OPEN SPACE DISTRICT; SECTION 28.2 USES PERMITTED; SECTION 28.3 USES PROHIBITED; CREATING SECTION 28.8 SECTION 28.7 LANDSCAPING, YARDS, AND SECTION 28.9 FENCES, WALLS, AND HEDGES; PROVIDING FOR OPEN SPACE S-2 DISTRICT PERMITTED USES AND DEVELOPMENT STANDARDS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF MARGATE, FLORIDA:

**SECTION 1**: The Code of Ordinances of the City of Margate, Florida, Appendix-A Zoning, ARTICLE XXVIII - OPEN SPACE S-2 DISTRICT, Section 28.2. Uses permitted, is hereby amended to read as follows<sup>1</sup>:

## Section 28.2. - Uses permitted.

No building or structure or part thereof shall be erected, altered or used, or land or water used, in whole or in part, for other than one (1) or more of the following specified uses, subject to the procedure specified in Section  $\frac{28.4}{27.4}$  of this Code following:

- (1) Boat ramp.
- (2) Bridle, foot or bicycle path.
- (3) Open land areas or commons.
- (4) Open water areas.

 SECTION 3: The Code of Ordinances of the City of Margate, Florida, Appendix-A Zoning, ARTICLE XXVIII - OPEN SPACE S-2 DISTRICT, Section 28.7. Landscaping, is hereby created to read as follows<sup>1</sup>:

## Section 28.7. - Landscaping.

All required yards and open spaces adjacent to streets and contiguous to residential property shall be planted and properly maintained with suitable planting in the form of grass, shrubs, hedges and trees to present an attractive appearance appropriate to the neighborhood. Parking areas shall be planted in accordance with Section 23-8 of this Code.

**SECTION 4**: The Code of Ordinances of the City of Margate, Florida, Appendix-A Zoning, ARTICLE XXVIII - OPEN SPACE S-2 DISTRICT, Section 28.8. Yards, is hereby created to read as follows<sup>1</sup>:

## Section 28.8. - Yards.

- (A) No parking area shall be located within 15 feet of any residential plot.
- (B) No structure, except municipal structures, fences or walls as hereinafter provided for, shall be located within 20 feet of any residentially zoned property nor within 25 feet of any public or private street.
- (C) No building or roofed portion of any structure,

  except municipal structures, shall be located within ten (10) feet of any plot line.
- (D) No required open space, yard, or setback area shall be used or developed for any purpose other than landscaping and walkways and/or driveways needed to serve the permitted use.
- **SECTION** 5: The Code of Ordinances of the City of Margate, Florida, Appendix-A Zoning, ARTICLE XXVIII OPEN SPACE S-2 DISTRICT, Section 28.9. Fences, walls, and hedges, is hereby created to read as follows<sup>1</sup>:
