Dear Ben:

Thank you for taking the time to allow me an overview of your project needs. Fast-Dry Courts, Inc. proposes to provide the scope of work described as build two (2) 12' x 60' artificial grass bocce courts with shared interior 6' concrete walkway and install (2) 20' light poles with (2) 4 brick led fixtures atop engineered precast foundations in middle of the outside bocce court perimeters. Prepare sub base by removing grass in proposed 30' x 60' area and dispose, add 4" of clean fill laser graded level and compacted. Install (2) 12' x 60' pressure treated wood containment borders with drilled weep holes with handicap access-ways into both bocce courts. Install high quality artificial turf in-filled with sand atop a compacted 4" concrete screening sand base. Turf will be secured at wood boarder. Install 60' x 6'w x 4"d concrete sidewalk between middle of bocce courts. Owner responsible for all electrical conduit, wiring, and hookups to each light pole for the total cost of **\$47,650.00**.
